EXPLANATORY MEMORANDUM

This Act repeals the Appropriation Act, 2020 and enacts the Appropriation Act, 2020 to authorise the issue from the Consolidated Revenue Fund of the Federation the total sum of ₦10,810,800,872,072 (ten trillion, eight hundred and ten billion, eight hundred million, eight hundred and seventy-two thousand, seven hundred and twenty-two Naira) only, of which ₦428,032,186,792 (four hundred and twenty-eight billion, thirty-two million, one hundred and eighty-six thousand, seven hundred and ninety-two Naira) only, is for Statutory Transfers, ₦2,951,710,000,000 (two trillion, nine hundred and fifty-one billion, seven hundred and ten million Naira) only, is for Debt Service, ₦4,942,269,251,934 (four trillion, nine hundred and forty-two billion, two hundred and sixty-nine million, two hundred and fifty-one thousand, nine hundred and thirty-four Naira) only, is for Recurrent (Non-Debt) Expenditure while the sum of ₦2,488,789,433,344 (two trillion, four hundred and eighty-eight billion, seven hundred and eighty-nine million, four hundred and thirty-three thousand, three hundred and forty-four Naira) only, is for contribution to the Development Fund for Capital Expenditure for the year ending on the 31st day of December, 2020.

An Act to repeal the Appropriation Act, 2020 and enact the Appropriation Act, 2020 to authorise the issue from the Consolidated Revenue Fund of the Federation the total sum of ₦10,810,800,872,072 (ten trillion, eight hundred and ten billion, eight hundred million, eight hundred and seventy-two thousand, seventy-two Naira) only, of which ₦428,032,186,792 (four hundred and twenty-eight billion, thirty-two million, one hundred and eighty-six thousand, seven hundred and ninety-two Naira) only, is for Statutory Transfers, ₦2,951,710,000,000 (two trillion, nine hundred and fifty-one billion, seven hundred and ten million Naira) only, is for Debt Service, ₦4,942,269,251,934 (four trillion, nine hundred and forty-two billion, two hundred and sixty-nine million, two hundred and fifty-one thousand, nine hundred and thirty-four Naira) only, is for Recurrent (Non-Debt) Expenditure while the sum of ₦2,488,789,433,344 (two trillion, four hundred and eighty-eight billion, seven hundred and eighty-nine million, four hundred and thirty-three thousand, three hundred and forty-four Naira) only, is for contribution to the Development Fund for Capital Expenditure for the year ending on the 31st day of December, 2020.

ENACTED by the National Assembly of the Federal Republic of Nigeria—

1. (1) The Accountant-General of the Federation shall, when authorised to do so by warrants signed by the Minister charged with responsibility for finance, pay out of the Consolidated Revenue Fund of the Federation during the year ending on the 31st day of December 2020, the sums specified by the warrants, not exceeding in the aggregate ₦10,810,800,872,072 (ten trillion, eight hundred and ten billion, eight hundred million, eight hundred and seventy-two thousand, seven-two Naira).  
Issue and appropriation of ₦10,810,800,872,072 from the Consolidated Revenue Fund for 2020.
- (2) The amount mentioned in subsection (1) shall be appropriated to the heads of expenditure as set out in the First Schedule to this Act.

- (3) No part of the amount shall be released from the Consolidated Revenue Fund of the Federation after the end of the year mentioned in subsection (1).
2. All amounts appropriated under this Act shall be released from the Consolidated Revenue Fund of the Federation only for the purpose specified in the First Schedule to this Act.

3. In the event that the implementation of any of the projects intended to be undertaken under this Act cannot be completed without virement, such virement shall only be effected with the prior approval of the National Assembly.

4. Any error in the Second Schedule to this Act that may hinder the implementation of projects and programmes in ministries, departments and agencies may be corrected through a corrigendum issued by the National Assembly provided that the total sum for the project or programme is not affected.

5. (1) The Accountant-General of the Federation shall, immediately upon the coming into effect of this Act, maintain a separate record for the documentation of revenue accruing to the Consolidated Revenue Fund in excess of oil price benchmark adopted in this Budget. Excess revenue.
- (2) The revenues specified in subsection (1) refer to revenues accruing from sales of government crude oil in excess of the approved benchmark price per barrel, the petroleum profit tax and royalty on oil and gas.
6. (1) No funds shall be paid out of the money arising from the record specified in section 5 (1) except by an Act or approval of the National Assembly. Authorisation.
- (2) The Accountant-General of the Federation shall forward to the National Assembly full details of funds released to the government agencies immediately such funds are released.
7. The Minister of Finance shall ensure that funds appropriated under this Act are released to the appropriate agencies and organs of government as and when due: Information on funds releases.
- Provided that no funds for any quarter of the fiscal year shall be deferred without prior waiver from the National Assembly.
8. The department of government charged with the responsibility of certifying that due process has been complied with in processing the implementation of projects shall ensure that all processes of approval are completed within the specified period as provided for in the Public Procurement Act. Due process certification.
9. All accounting officers of ministries, parastatals and departments of government who control heads of expenditures shall, upon the coming into effect of this Act, furnish the National Assembly on quarterly basis with detailed information on – Act No. 14, 2007.
- (a) the internally generated revenue of the agency in any form; and
- (b) all foreign and domestic assistance received from any agency, person or organisation in any form.
- Information on internally generated revenue, domestic and foreign assistance.
10. The Economic and Financial Crimes Commission (EFCC) and the Nigerian Financial Intelligence Unit (NFIU) are authorised to charge and defray from all money standing in credit to the units as revenues or penalties or sanctions at 10% for technical setup and operational cost at the units in this financial year. Power of EFCC and NFIU to utilise 10% of revenue generated from penalties and sanctions.
11. The detailed estimates of expenditure are set out in the Second Schedule to this Act. Detailed estimates.

12. In line with the provisions of section 318 of the Constitution of the Federal Republic of Nigeria, this Act expires after 12 months, starting from 1st day of January to 31st day of December, 2020 when assented to. Expiry.
