# **1** Summary of Performance

# 1.A Introduction

This Budget Performance Report for Adamawa State is prepared quarterly, and issued within four weeks from the end of each quarter.

This report cludes, the approved budget appropriation for the year 2021 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations. Quarter 1 performance is assessed against the 2021 original budget. No supplementary or revised budget has been passed to date in 2021.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2208 as applicable

This Budget Performance Report is produced by the Office of the Account General, Adamawa State, and published on the Adamawa State Government website.

# **1.B** Revenue Performance

The State Government budgeted the sum of ¥140.034 billion and realised ¥16.905 billion representing 12.10% of budget performance for the first quarter period ended 31<sup>st</sup> March 2021 so far the performance has been very fair we are on course to achieving the 100% performance.

# **1.C** Recurrent Expenditure Performance

The sum of-N67.216 billion been budgeted out of which N12.127 billion has been expended representing 18.0% of performance as at the first quarter, so far the trend of recurrent expenditure may require revised budget before the end of the fiscal Year.

# 1.D Capital Expenditure Performance

The Capital expenditure was allotted the sum of \$72.812 billion in the 2021 Approved budget which permitted the spending of N 2.603 billion on the infrastructural development of the State.

# **1.E Conclusions**

The State Government has performed fairly well in terms of revenue generation, and expenditure execution for the period ended 31st march, 2021.
