1 Summary of Performance

1.A Introduction

This Budget Performance Report for EDO State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes the original approved budget appropriation for the year 2023 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarters Q1 and Q2, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This half year report is assessed against the 2023 Original budget.

The core economic classifications refer to:

- Personnel – Economic Sub-Account Type 21
- Overheads - Economic Account Class 2202
- Capital - Economic Sub-Account Type 32
- Others - Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Office of the Accountant General in collaboration with the Ministry of Finance, Budget Economic Planning and Development. It is published on the Edo State (www.edostate.gov.ng/financials) website.

The Edo State 2023 Budget of N321.35 billion christened “Budget of Resilience and Transformation” was signed into law on the Wednesday 30th of December, 2022.

The Budget had an Opening Balance: N5.00 billion, Statutory Allocation: N64.65 billion, Value Added Tax (VAT): N41.19 billion, Other FAAC Revenues: N79.61 billion, Internally Generated Revenue (IGR): N60.37 billion, Aids and Grants: N4.00 billion, Domestic loan: N3.00 billion and Foreign Loan: N16.45 billion. Other Expected Capital receipts stood at 47.08 billion. On the expenditure side, Personnel Cost is N42.89 billion, Overhead Cost: N40.46 billion, Capital Expenditure: N185.64 billion, Pensions and Gratuity: N15.10 billion and Public debt charges: N36.82 billion.

1.B Revenue Performance

The Edo State Government share of FAAC as at 30th June, 2023 was N61.76 billion, showing an average quarterly performance of 67%, this represents 33.3% of the full year budget estimate of N185.46 billion. It shows that FAAC Receipts are performing at 33% below expected receipts on a quarterly basis. A critical look at the analysis shows that as at half year, statutory allocation performed at 53%, while VAT stood at 76% and other FAAC revenues amounted to 73%. So expectation are that with the removal fuel subsidy, there would be a significant growth in the FAAC receipts to the State.

The Independent Generated Revenue (IGR) as at 30th June, stood at N24.84 billion representing 82% of the Budgeted receipts. Q2 performance was 66% which is a decline from Q1 performance of 98%. IGR realised represents 41.1% of the full year estimate of N60.37 billion.

Other Receipts which include Loans, grants and other capital receipts amounted to N6.27 billion representing 8.9% of the full year expected receipts, we are yet to realise any funds from Grants and other sources expected.

1.C Recurrent Expenditure Performance

The total recurrent expenditure (including personnel and overhead cost) as at 30th June, 2023 was N60.47 billion, which is 44.6% of the total recurrent expenditure of N135.71 billion in the approved 2023 budget. Of this amount 45% is attributable to Personnel cost and other personnel emoluments while the remaining 55% is attributable to overheads. It should be noted that total recurrent expenditure has maintained an average expenditure rate of 90% on a quarterly basis.

Personnel Cost which includes salaries, pensions and gratuity payments amounted to N27.32 billion from N13.64 billion in Q1. This amount represents 47% of the total Personnel Budget of N58.18 billion. On a quarter-by-quarter basis, personnel cost increased from 86% in Q1 to 91% in Q2.

Mid-Year Overhead expenditure was N33.15 billion which is 43% of the approved budget. On a quarterly basis, average performance stood at 84%.

1.D Capital Expenditure Performance

Capital Expenditure as at 30th June, 2023 is N37.19 billion which is 20% of N185.64 billion (total Capital Expenditure) for Fiscal Year 2023. Quarter-to quarter performance shows an average of 41%. Though the decline is attributable to the rains which slow the pace of work especially infrastructural works.

1.E Conclusions

Despite the shortfall in the Statutory allocations to the State and other revenue projections, the State Government has been consistent and placed the monthly payment of workers' salaries, including pensions and gratuities to retirees as one of its topmost priorities.

Even with the rains, the state government is still under taking the construction of critical infrastructure within the state, these includes, the construction of the Stella Obasanjo Hospital, the College of Agriculture Iguoriakhi, the School of Nursing Sciences. The civil service transformation is also given its top priority in the Budget implementation.

Though with these landmark projects on-going it is still assumed that there is a slow pace on the implementation of the Capital Expenditure. This can also be attributable to the rains and it is anticipated that once the rain subsides, there would be an improvement in the capital expenditure implementation across the State.
