# 1 Summary of Performance

## 1.A Introduction

This Budget Performance Report for Osun State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes the original approved budget appropriation for the year 2022 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for the year to date, and balances against each of the revenue and expenditure appropriations.

This Q1 report is assessed against the 2022 Approved budget.

The core economic classifications refer to:

- Personnel – Economic Sub-Account Type 21
- Overheads - Economic Account Class 2202
- Capital - Economic Sub-Account Type 32
- Others - Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Ministry of Economic Planning and Budget in conjunction with the Office of the Accountant-General, Kano State and published on the Ministry of Planning and Budget State website.

## 1.B Revenue Performance

The Revenue comprises of the:

- i. Recurrent Revenue
- ii. Capital Receipts

In the 2022 Approved Budget, the Total Revenue was projected to be ₦ 221,235,185,147.00. The actual revenue from January to March 2022 (Q1) is ₦36,635,729,350.58 resulting to a variance of ₦184,599,455,796.42 which gives a Revenue performance of 16.6%

The Government Share of FAAC and the Independent Revenue forms part of the Recurrent Revenue.

Table 1 shows the breakdown of the Recurrent revenue performance.

The 2022 Recurrent Revenue Budget was projected to be ₦159,726,217,984.68 with an actual of ₦35,235,729,350.58 giving a variance of ₦ 124,490,488,634.10 resulting to a Performance of 22.1% out of which the Government share of FAAC is ₦121,573,770,693.00 with an actual of ₦ 26,462,467,057.97 giving a variance of ₦ 95,111,303,635.03 resulting to a performance of 21.8% while the Independent Revenue was projected to be ₦38,152,447,291.68 with an actual of ₦8,773,262,292.61 giving a variance of ₦ 29,379,184,999.07 resulting to a Performance of 23%.

Some revenue items which were not budgeted in the year 2022 recorded an actual figure in the first quarter of the year. This resulted in improved budget performance during the quarter. Meanwhile, necessary steps will be taken to revise the budget before the end of the year in order to capture these items.

The Capital Receipts was projected to be ₦ 45,845,950,336.00 with an actual of ₦

1,400,000,000.00 giving a variance of ₦ 44,445,950,336.00 resulting to a Performance of 3.1%.

## 1.C Recurrent Expenditure Performance

The Recurrent Expenditure is divided into:

- i. The Personnel Cost
- ii. Other Recurrent Expenditure

The 2022 Recurrent Expenditure Budget was projected to be ₦99,379,288,003.12 with an actual of ₦26,618,283,781.97 giving a variance of ₦72,761,004,221.15 resulting to a Performance of 26.8%.

The Personnel cost was projected to be ₦66,036,850,594.91 with an actual of ₦ 17,704,608,952.38 giving a variance of ₦ 48,332,241,642.53 89 resulting to a Performance of 26.8%.

The Other Recurrent Expenditure was projected to be ₦33,342,437,408.21 with an actual of ₦8,913,674,829.59 giving a variance of ₦24,428,762,578.62 resulting to a Performance of 26.7%.

It is pertinent to note that all over expenditure against the approved budget will be formalised in the supplementary budget before the end of the 2022 fiscal Year

## 1.D Capital Expenditure Performance

The Capital Expenditure was projected to be ₦121,855,897,143.88 with an actual of ₦2,939,869,367.04 giving a variance of ₦118,916,027,776.84 resulting to a Performance of 2.4%. At the first quarter, the activities are mostly low because the revenues are just flowing into the State including capital receipts.

## 1.E Conclusions

In Conclusion, the total budget size for 2022 was projected to be ₦221,235,185,147.00 giving an actual expenditure performance of ₦29,558,153,149.01 as at first quarter with the corresponding revenue performance for the period as ₦ 36,635,729,350.58. This represents 13.4% for expenditure and 16.6% for revenue.

Although, the general expenditure performance is low but the State anticipates tremendous performance in the subsequent quarters because there would have more accumulated revenue to implement the budget and capital expenditure/ projects base on the tough fiscal reforms introduced by the state. The state is also working hard to harness more of its capital receipt projections so as to improve the performance in subsequent quarters.
