1 Summary of Performance

1.A Introduction

This Budget Performance Report for Katsina State is prepared quarterly and issued to the public within four (4) weeks after the end of each quarter.

This report includes the approved budget appropriation for the year 2022 as well as the revised budget (which includes a number of virements) against each organizational unit for each of the core economic classification of expenditures such as Personnel, Overheads, Capital, and Others; the actual expenditures for the fourth quarter (Q4), attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q4 report is assessed against the 2022 revised budget.

The core economic classifications refer to:

- Personnel – Economic Sub-Account Type 21
- Overheads – Economic Account Class 2202
- Capital – Economic Sub-Account Type 32
- Others – Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Ministry of Budget and Economic Planning Katsina State and published on the Katsina State website www.katsinastate.gov.ng.

Furthermore, it is to be noted that as at the time of this report, not all revenues (IGR and Receipts) were able to be recorded, even though it does not represent significant amount that could change the face of this report due to challenging at some MDAs and time factor but total and more details would be expected to be disclosed in the final account report of the Office of the Auditor General for the State.

1.B Revenue Performance

The Katsina State Approved a Total Revenue of N323,296,220,961.00 for the year 2022 from numerous sources with Recurrent Revenue anticipated to generate the sum of N168,293,660,284.00, Opening Balance of N12,500,000,000.00 whereas Internal and External Receipts (Aids & Grants) and Loan's inflow funds was N142,502,560,677.00.

The 2022 quarterly pro-rata was anticipated to generate N77,699,055,240.25 from all inflows excluding opening balance to enable the State executive its budget 100%. However, N192,330,801,064.29 (59.5%) was realised including a recurrent revenue of N102,429,435,211.86 (60.9%) and the Capital Receipts of N 69,024,575,417.53 (48.4%). Additionally, the projected opening balance for the Fiscal Year 2022 was set at N12.5bn but the Auditor General's report of the Accounts of State Government FY 2021 the closing balance as at 31st December, 2021 was actually N20,876,790,434.90 which should be the opening balance of FY 2022.

The State's Budget Performance for the year (January to December 2022), the inflows from Statutory Allocation received was N88.6bn and Internal Generated Revenue (IGR) was N13.9bn representing 77.0% and 26.0% respectively. The Capital Receipts consisting of Grants & Aids of 32.9bn and Loans of 36.0bn which signify 37.7% and 65.4% respectively.

Notwithstanding, various efforts are put in place to manage the security challenges experienced in many parts of the State, thus hampered the effort of Internal Revenue Service to record outstanding performance.

1.C Recurrent Expenditure Performance

The Recurrent Expenditure covers Personnel Emolument, Pension, Gratuities, Overhead Cost and Other Recurrent Expenses such as Debt Repayments, Transfers etc. The Personnel Costs performance including social benefits in the Q4 amounted to 11.7bn, while Overhead and Other Recurrent costs in the Q4 is at the tune of 4.4bn and 5.6bn respectively. The total for the year under reference was as follows:

- i. Personnel Costs including social benefits: N41,662,189,829.19 (86.6%)
- ii. Overhead: N16,315,074,248.34 (76.3%)
- iii. Other Recurrent Costs: N22,647,158,428.51 (72.5%)

The Government commitment to the welfare of her workforce has never been underrated, salaries and pensions are paid as at when due, while retirement benefits are settled in trenches.

1.D Capital Expenditure Performance

The approved Capital Expenditure for the year stood at N222.5bn and for the Government to executive all its Capital budgetary allocation, N55.8bn are expected to be allocated quarterly mainly on Projects that will address infrastructure and other socio-economic challenges. However, Capital expenditure committed for the Q4 stand at only N18.1bn which only 8.2% and overall spending for the year was 76.1bn (34.2%) only.

In view of the above, the State need to commit more resources on the Capital Projects and programmes that would improve the Socio-Economic status of the State, this would drastically close the deficit.

1.E Conclusions

The Fourth Quarter 2022 (Q4) Budget Performance on capital expenditure reflect the accomplishment in the execution of some vital infrastructural projects such as:

- a. Completion of 2No. underpasses in Katsina Metropolis
- b. Substantiate progress was also recorded for the construction of flyover within Katsina Metro
- c. Construction and rehabilitation of grazing reserves including provision of essential facilities such as Clinics, Nomadic Schools, Veterinary Centres, cattle routes, feeds etc
- d. Renovation and some construction of Primary and Secondary Schools state-across the State.
- e. Ecological intervention projects
- f. Expansion & improvement of Water Supply schemes
- g. Continual construction of Teaching Hospital and faculty of Medical Sciences under State University
- h. Continual renovation and provision of primary healthcare service such as Comprehensive Healthcare Centres and Primary Healthcare Centres across the 34 Local Government Areas.

The overall Budget Performance for the year 2022 shows there is still need for the State to look into poor performance of IGR and Capital Receipts that became huge source of funding the budget estimates, and this has badly affected the performance of capital project during the year.
