1 Summary of Performance

1.A Introduction

This is a progress Budget Performance Report of Kwara State, prepared quarterly to examine the level of success attained in the implementation of 2022 Approved Budget. It is issued within four weeks from the end of each quarter.

This report includes the original approved budget appropriation for the year 2022 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q2, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Ministry of Planning and Economic Development and published on the Kwara State website.

1.B Revenue Performance

The total actual revenue for the second quarter of year 2022 was \\$32,898,361,029 which shows 2.9% decrease as against \\$46,438,937,350 including opening balance of \\$12,566,697,511. The aggregate revenue inflow year to date, as of June, was \\$99,913,749,419 (52.7%) including an opening balance of \\$33,143,148,551 (closing balance of audited financial statement of the State Office of Accountant General). From \\$32,898,361,029 received in the second quarter as total revenue, a sum of \\$14,957,458,617 was state share of Federal Allocation representing 26.2% performance against the expected Original Budget of \\$57,009,117,992 for the Year 2022. It shows 10.2% increase compared to the previous quarter. The aggregate year to date was \\$28,530,396,252 (58.5%). The IGR in the second quarter was \\$7,361,106,363 accounting for 23.9% performance from the expected Original Budget of \\$30,838,049,516. Capital Receipt in the second quarter was \\$10,579,796,049 accounting for 14.7% against expected Original Budget of \\$71,770,320,116. There is 9.8% increase in the Capital Receipts in the second quarter compared to the previous quarter. Much more commitment of the present administration to meet the requirement of grant by the donor agencies accounted for this achievement.

1.C Recurrent Expenditure Performance

 State Government and Transfer to CDF (Service Wide Vote) in the budget of Ministry of Finance. Religious pilgrimage contribution, a one-off activity, was expended on Muslim pilgrimage during this quarter.

1.D Capital Expenditure Performance

The total capital expenditure in the second quarter was \\ 11,322,306,429 which fell below the projection of \\ 26,362,343,308 for the quarter. This represents 42.9% performance of the expected quarterly estimates and 10.7% performance against the expected Original Budget of \\ 105,449,373,234. Meanwhile, the total actual capital expenditure performance from January to June 2022 was 18,540,912,874 (17.6%). The improvement in the Budget performance in the mid-year compared to the previous year was due to the implementation of many programmes/projects by the government with the aim of boosting the economic activities in the state. These projects include Construction of Roads, Construction of International Conference Hall, Construction of Infrastructure (Innovation Hub), Construction of Flyover Bridge, Construction of Kwara Garment Production Village, etc.

1.E Conclusions

The State is committed to implement the budget in line with the provisions of the Kwara State Appropriation Law and Finance Act 2022. Priority attention has been paid to capital projects that will boost the economic activities in the States. And there is ongoing effort to improve the State IGR capacity.
