1 Summary of Performance

1.A Introduction

This Budget Performance Report for Plateau State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes the approved budget appropriation for the year 2021 (January to March) against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations. Quarter 1 performance is assessed against the 2021 original. No supplementary or revised budget has been passed to date in 2021.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21000000
- Overheads Economic Account Class 22020000
- Capital Economic Sub-Account Type 23000000
- Others Economic Account Classes 2203-2208 as applicable

This Budget Performance Report is produced by the Ministry of Budget and Economic Planning and Ministry of Finance Plateau State website.

1.B Revenue Performance

From the Budget overview Table I the Revenue from the Federal Government Revenue to the State is N13,043,400,515.43 representing 17.4% of the Approved Government Share of FAAC (Statutory Revenue). While the IGR stands at N7,275,087,769.74 only representing 33.5% of the Approved Estimate.

The above Recurrent Revenues has a total performance of 21% showing the total collection of N20,318,488,285.17 only.

Donor agencies also contributed N618,535,235 only as Aids and Grants to the State representing 4.7% and 1.2%. of the Approved Aids and Grants and Total Capital Receipts, respectively.

About 21 MDAs are yet to report collections of revenue and 28 revenue codes did generate income probably as a result seasonality of some of the revenues or the MADs are yet to generally make collections and remit same for the Quarter.

1.C Recurrent Expenditure Performance

The personnel emolument of the first three months of the year has a 17.3% of Total Personnel Emolument performance with an actual of (N6,9383,92,692.40) only. Government spending on total Overhead cost amounted to N10,173,358,941.99 representing 20.3% Of the Total Recurrent Expenditure.

The QI Total Recurrent Expenditure Performance stands at N17,111,751,634.39 representing 19.0% of then Approved Recurrent Estimate of N90,193,029,723.00 only.

1.D Capital Expenditure Performance

The total sum of N2,194,569,239.93 representing 3.8% of the Approved Capital Expenditure was spend on projects in the State.

a. Rehabilitation/Construction of Roads = 1,450,205,171.45 which represents 66% of expenditure



- b. Construction/Rehabilitation other than roads = 392,424,430.00 (18%)
- c. Purchases = 303,910,530.01 (14%)
- d. Others = 48,029,108.47 (2%)

1.E Conclusions

Summarily, there is a collection of N20,937,023,520.17 representing 14.2% of the total 2021 Approved Revenue. While the Q1 expenditure stand at N19,306,320,874.32 representing 13.1% of the Approved Revenue.
