1 Summary of Performance

1.A Introduction

This Budget Performance Report for Rivers State is prepared quarterly, and issued within four weeks from the end of each quarter.

This report includes, the approved original budget appropriation for the year 2021 (no supplementary or revised budget has been passed to date in 2021) against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q2, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21, and Economic Account Class 2201
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2209

This Budget Performance Report is produced by the Account General Department/ Ministry of Finance/ Ministry of Budget and Economic Planning of Rivers State, and published on the Rivers State website.

1.B Revenue Performance

The total recurrent revenue for Q2 2021 recorded a performance of 21.4% of the approved budget for 2021, whereas, the cumulative performance for Q1 and Q2 is 45.2%. Further breakdown of the recurrent revenue performance indicates as follows:

- i. FAAC: 19.3% of the total appropriated revenue from the Federation Account Allocation Committee was realized in the Q2 of 2021, and indicates 37.5% performance for Q1 and Q2.
- ii. IGR: Independent revenue generation by the State accounted for 25.6% of the appropriated amount for the fiscal year 2021, and a cumulative percentage of 60.2 for Q1 and Q2.

1.C Recurrent Expenditure Performance

Total recurrent expenditure in Q2 of 2021 recorded 24.1% performance, and a cumulative of 38.9% for Q1 and Q2 against the approved appropriation for the fiscal year 2021. The breakdown of units of the recurrent expenditure shows as follows:

- i. Personnel Cost recorded a performance of 19.7% in Q2 and a cumulative performance of 39.7% for Q1 and Q2 of the fiscal year 2021.
- ii. Overhead Cost registered a performance of 22.8% in Q2 and a cumulative of 40.2% for Q1 and Q2 of 2021.

1.D Capital Expenditure Performance

The capital expenditure performance for Q2 2021 indicates a percentage of 41.8 and a cumulative performance of 73.1% for Q1 and Q2 of the approved budget for fiscal year 2021. The Government is poised to invest massively in infrastructural development. This accounts for the high level of capital expenditure in the first two quarters of 2021 fiscal year.

1.E Conclusions

The budget performance for Rivers State in Q2 is a demonstration of the administration's drive for infrastructural and economic transformation of the State.

The general overview of the budget performance for Q1 and Q2 of 2021 indicates a total revenue performance of 63.3% as against the approved total revenue estimate for the fiscal year 2021, while the total expenditure for the same period under consideration recorded 59.3% of the total approved expenditure estimate for the fiscal year 2021.
