1 Summary of Performance

1.A Introduction

This Budget Performance Report for Sokoto State is prepared quarterly and issued within four weeks from the end of each quarter.

This report includes the approved budget appropriation for the year 2021 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the first Quarter, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations. No supplementary or revised budget has been passed to date in 2021.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2208

This Budget Performance Report is produced by the Sokoto State Ministry of Budget and Economic Planning and published on the 28th April, 2021 on the State website.

1.B Revenue Performance

The State Budgeted a Total Revenue of N176,685,535,663 for the year 2021 from various sources with Recurrent Revenue Expected to generate N95,838,296,430.67 while N69,506,359,754 was expected from Capital Receipts. The first Quarter of 2021 pro-rata was expected to generate N41,336,164,046 but the actual amount generated was N20,464,459,263 consisting of Recurrent Revenue of N17,140,692,005 and Capital Receipts of N3,323,767,257 reflecting a Performance of 49%. The Expected Statutory Allocation also fell below the amount expected for the Quarter due to harsh global economic condition resulting in 84% Performance against the prorated budgeted amount for the Quarter. The Internally generated Revenue for the Quarter closed with a performance of 45% against the Budgeted amount for the Quarter which is principally due to the impact of reliefs granted by the Government in respect of COVID-19. The Overall Performance of Revenue against the Budget size stood at 27.3% (inclusive of opening balance) as against Expected 25% for the Quarter.

1.C Recurrent Expenditure Performance

The Recurrent Expenditure is made up of Personnel Costs including Pension and Gratuities, Overheads and Other Expenses relating to Debt Servicing. Personnel Costs Budgeted for the Quarter ended with a performance of 92% and 23% of the entire year Budget as against prorated 25%. Other recurrent expenditure had a performance of 63% for the Quarter and 16% of the entire year Budget as against prorated 25%.

1.D Capital Expenditure Performance

Capital Expenditure of N95,527,130,973 was approved for the year 2021. The Projected pro-rata performance for the Quarter ended with a performance of 30% and 7.4% of the entire year Capital Budget.

1.E Conclusions

The Global Economic impact of the pandemic is a major factor affecting effective budget implementation as Government effort at mobilizing revenues from the citizens became more challenging and has called for more innovative and cost-effective approaches to Governance. Sokoto State Government is committed to harnessing all available economic opportunity to enhance the Budget Performance in the remaining months of the year 2021 and beyond.
