1 Summary of Performance

1.A Introduction

This Budget Performance Report for Taraba State is prepared quarterly and issued within four weeks from the end of each quarter.

This report includes the approved original budget appropriation for the year 2022 which was passed by the Taraba State House of Assembly in 2022, against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q2, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations. It compares Q2 performance to the approved original Budget (a revised budget with virements between revenue and expenditure budget lines will be consider within the 2022 fiscal year in order to address already identified over and under performance of so many sub – heads).

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2208 as applicable

This Budget Performance Report is produced by the Department of Budget, Ministry of Budget and Economic Planning and published on the Taraba State Government website.

Introduction

Taraba State of Nigeria being one of the second - tier of the Nation cannot be an exception to the Covid-19 pandemic and current realities. Over 90% of the state's revenue comes from the Federation Account Allocation Committee (FAAC) which is already affected by the pandemic. The 2022 Budget was tagged "Budget of hope and Consolidation" focused on ensuring continuity, consolidation, development and improving revenue base of the state.

Key Assumptions and Projections

The 2022 Budget document was based on some key Macro-Economic assumptions such as exchange rate, IGR growth rate, oil production, prevailing Crude Oil price which determines the State share from FAAC and VAT.

1.C1.B Revenue Performance

The bulk of the revenue expected for the quarter was from government share of Federation Account Allocation Committee (FAAC). It was expected that this source would bring in the sum of N69,662,234,050.11 for the Full Year but data available shows that the sum of N26,186,118,144.34 was received from Government Share of FAAC (Statutory Allocation) Quarter two (Q1 - Q2) or 37.6% year to date leaving a balance of N43,476,115,905.77 or 62.4% as at the second quarter of FY 2022. The Independent Revenue (IGR) estimated target was N10,311,500,000.00 but N4,302,912,567.43 or 41.7% was collected representing a good start performance as at second quarter of FY 2022.

In addition, revenue from Capital Development Fund (CDF) receipts that has flown into the state as internal loans in the quarter was N6,223,745,992.00 and N15,084,269,992.55 as against Full Year budgeted figure of N51,087,742,622.71 and reflecting 29.5% in Q1 – Q2 Year to Date. Furthermore, other revenue from aids and grants that has flown to the state is N875,860,539.90 as performance against the approved figure of N19,492,886,524.00; draw-down from International Development Association (IDA) as advance payment for Nigeria CARES Program has flown to the State during the First Quarter period amounting to N900,000,000.00, while nothing was recorded during the second quarter.

1.D1.C Recurrent Expenditure Performance

Consequently, in recent years the state is keen on subjecting the recurrent expenditure to realistic projections in order to free more of its resources for capital development. A split of 60% for capital expenditure and 40% for recurrent expenditure was therefore projected in order to achieve the fiscal target of the state.

In the light of the above, the recurrent expenditure items estimates were N78,072,587,679.90 with a performance of N36,545,331,578.63 representing 46.8% leaving a budget balance of N41,527,256,101.26 or 53.2% in Q1 - Q2 to date fiscal year, 2022. In addition, some of the expenditure line items has over performed, these will be carefully handled soon during the year budget revisions.

1.E1.D Capital Expenditure Performance

The capital expenditure is a pool of funds used for capital development. In view of its importance in the budget, it was allocated the sum of N71,712,308,716.92 which represents about 47.88% of the total budget size. However, actual capital expenditure performance stood at N9,342,989,438.99 performance as at the period under review (Q1-Q2) to date or 13.0%. This is not a fair performance when compared with previous years' budget performances. Other figures can be easily viewed and seen on the tables attached below for detailed analysis.

1.F1.E Conclusions

The 2022 budget aimed at restoring and stabilizing the state economy driven by the government's giant strides on the principle of transparency, accountability and citizen's participation in governance. It also aimed at making Taraba the leading economy in the North East sub-region by 2025.

Notwithstanding, the review of the 2022 Year – To – Date performance during the second quarter especially from the capital expenditure, shows a poor performance, though there is still room for improvement in the future. The state is making efforts to focus more on implementing capital projects and curtail recurrent expenditure to a minimal level for this will help the state to achieve its developmental targets. Conversely, based on data available to date it shows that some MDAs sub – heads for both revenue and expenditure has exceeded its budgetary provisions. The State will tidy up all these variances by revising its 2022 Budget together with virement where necessary.
