1 Summary of Performance

1.A Introduction

This Budget Performance Report for Taraba State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes the original approved budget appropriation for the year 2024 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q1 report is assessed against the 2024 original.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Ministry of Finance, Budget & Economic Planning and published on the Taraba State Government official website.

1.B Revenue Performance

The bulk of the revenue expected for the year was from government share of Federation Account Allocation Committee (FAAC). It was expected that this source would bring in the sum of N112,428,967,192.38 data available shows that the sum of N25,936,964,233.30 was received from Government Share of FAAC (Statutory Allocation and Value Added Tax) in quarter one (Q1) leaving a balance of N86,492,002,959.08, this indicates a good performance from this revenue source.

The Independent Revenue (IGR) estimated target was N27,830,439,124.10 but N1,980,371,489.40 was collected representing a poor performance as at First Quarter of FY2024.

In addition, revenue from other receipts (Capital Development Receipts, Aids and Grants) that has flown into the state as at First Quarter was N6,275,903,031.10 as against Full Year budgeted figure of N169,629,119,345.08 with a balance of N163,353,216,313.98 representing 3.7% as performance to date.

1.C Recurrent Expenditure Performance

Presently, the state is keen on subjecting the recurrent expenditure to realistic projections to free more of its resources for capital development. A split of 60% for capital expenditure and 40% for recurrent expenditure was therefore projected to achieve the fiscal target of the state.

In the light of the above, the recurrent expenditure items approved figure was N111,445,705,534.87 with a performance of N20,933,871,839.62 representing 18.8% leaving a budgeted balance of N90,511,833,695.25. In addition, some of the expenditure line items (head and sub-head) has over performed or overspent, these will be handled during the year budget amendments to ensure discipline in the implementation period under review.

1.D Capital Expenditure Performance

The capital expenditure is a pool of funds used for capital development. In view of its importance in the budget, it was allocated the sum of N201,942,820,126.69 which represents about 64.43% of the total budget size. However, actual capital expenditure performance stood at N8,760,282,092.30 performance as at the period under review (Q1) or 4.3%. This is not a fair performance when compared with previous years' budget performances, but it could be provisional figures as it awaits comparison with the FY2024 Audited Financial Statements.


1.E Conclusions

The 2024 budget aimed at fostering sustainable growth, social development, agriculture, and rural development, infrastructure development, governance, and public financial management. Thereby restoring and stabilizing the state economy driven by the government's giant strides on the principle of transparency, accountability, and citizen's participation in governance. It also aimed at making Taraba the leading economy in the Northeast sub-region by 2040.

Notwithstanding, the review of the 2024 Year — To — Date performance during the First Quarter especially from the capital expenditure, shows a poor performance, though there is still room for improvement in the future. The state is making efforts to focus more on implementing capital projects and curtail recurrent expenditure to a minimal level for this will help the state to achieve its developmental targets. MDAs with overspending will be handled within the fiscal year Budget amendments before the next period. This is to ensure discipline in the implementation period under review. The opening balance within the quarters is flexible to change in the fiscal year.
