GENERAL PROVISIONS

Long Title	A Law to make Supplementary Provision for the Sum of One Hundred and Six Million, Eight Hundred and Thirty Seven Thousand, One Hundred and Forty Four Naira, (N106,837,144.00) only for the Services of the Government of Abia State of Nigeria for the year ending 31 st Day of December, 2021 and for other related purposes.
Enactment	BE IT ENACTED by the House of Assembly of Abia State of Nigeria as follows:
Citation and Commencement	Part I: Preliminaries 1. This Law may be cited as the Abia State of Nigeria Supplementary Appropriation Law, 2021 and shall be deemed to have come into force on the 1 st day of June, 2021.
Interpretation	2. In this Law except the context otherwise requires: “ Accountant General ” means the Accountant-General of Abia State; “ Governor ” means the Governor of Abia State; and “ State ” means Abia State of Nigeria.

Whereas by the Abia State of Nigeria Appropriation Law 2021, a sum not exceeding One Hundred and Thirty-One Billion, Eight Hundred and Fifteen Million, Seven Hundred and Fifty-Two Thousand Naira, (N131,815,752.00) only was appropriated for the services of the Government of Abia State of Nigeria for the year ending 31 st day of December, 2021.
Supplementary Appropriation of N106,837,144	4. Whereas it was deemed necessary that certain further sums be appropriated at the tune of One Hundred and Six Million, Eght Hundred and Thirty Seven Thousand, One Hundred and Forty Four Naira (N106,837,144.00) only be expended on the services of the Government of Abia State of Nigeria for the year ended 31 st day of December, 2021.
