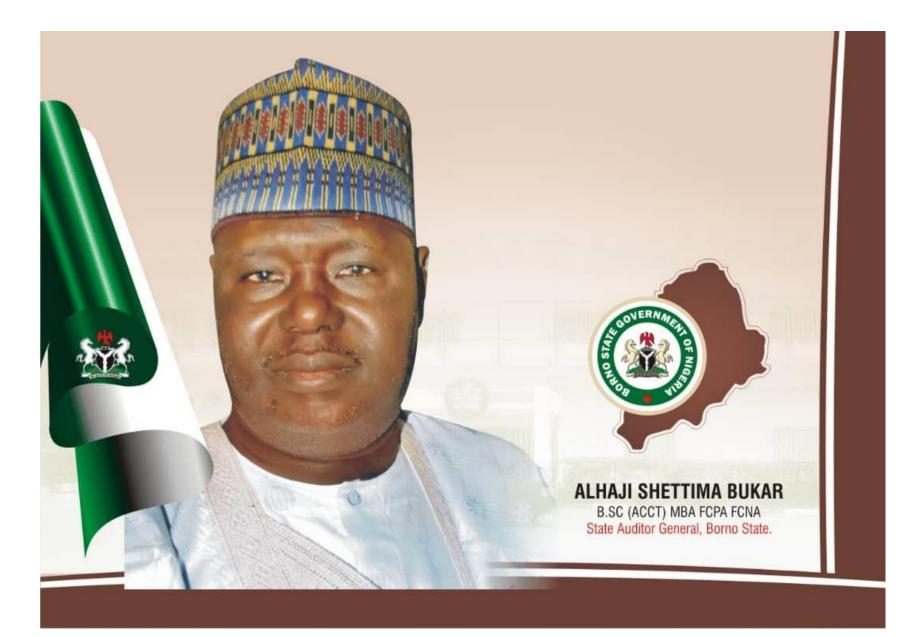

### THE ANNUAL REPORT OF THE STATE AUDITOR GENERAL ON THE ACCOUNTS OF THE GOVERNMENT OF BORNO STATE FOR THE YEAR ENDED 31<sup>ST</sup> DECEMBER, 2018 TO THE BORNO STATE HOUSE OF ASSEMBLY.

### 1.0 INTRODUCTION

In compliance with the provisions of Section 125 (2) of the Constitution of the Federal Republic of Nigeria 1999, (As amended); Public Sector Auditing Standards 1998, and the Audit Law (Chapter 15) of the Laws of Borno State of Nigeria, 1994, the accounts of the Government of Borno State and the Financial Statements for the year ended 31st December, 2018 together with the individual accounts maintained by Ministries, Departments and Agencies have been audited under my direction. My responsibility in that direction is to express an opinion on the financial statements based on audit. I conducted my audit in accordance with the laws and standards quoted above. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance as to whether the financial statements are free from material misstatement.

An audit involves the performance of procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the Auditors judgment. The audit also includes an evaluation of the appropriateness of the accounting polices used and the reasonableness of the overall presentation of the financial statements.

I believe that the audit evidence we have obtained is sufficient and enough to provide a basis for my audit opinion.

I have certified the individual accounts maintained by Ministries, Departments and Agencies (MDAs) as in order, subjects to comments contained in this report while irregularities have been communicated through various letters, reports and queries to the respective Accounting Officers. And all unresolved issues are presented in this report.

### **Responsibility for Accounts and Financial Statements**

The Accountant General, pursuant to the provisions of the Constitution of the Federal Republic of Nigeria 1999 (As Amended), Financial Regulation (Chapter 1) and the Public Finance (Control and Management) Law 1958 (As Amended is responsible for the keeping and maintenance of the various books of accounts that provides adequate and reasonable assurances that transactions are appropriately recorded in line with statutory authority; and for the preparation of the State's Annual Financial Statements and their related Notes.

### Submission of Financial Statements

The Annual Financial Statements of the Government of Borno State for the year ended 31<sup>st</sup> December 2018 together with their related Notes were first submitted to me on 11<sup>th</sup> June, 2019 by the Accountant General, Borno State. Following observations raised pursuant to the audit, the Statements were returned to the Accountant General for correction and eventually the clean copy was received on 4<sup>th</sup> July, 2019. This was finally confirmed by me and found to be in order and reproduced as part of this report from pages 41 to 95.

Therefore, in accordance with the requirement of Section 125 (5), I hereby submit the Annual Report of the State Auditor General on the accounts of the Government of Borno State for the financial year ended 31<sup>st</sup> December, 2018 to the Honourable House of Assembly of Borno State for consideration.

### AUDIT CERTIFICATE

The audit was conducted in conformity with the Public Sector Auditing Standards and in accordance with the Audit Law (Chapter 15) of Borno State of Nigeria, 1994.

Proper returns have been rendered by Ministries, Departments and Agencies/Parastatals in compliance with the Public Finance (Control and Management) Laws 1958 (As Amended); and I have obtained the information and explanations necessary that I required for the audit.

### **Opinion**

In compliance with Section 125(5) of the Constitution of the Federal Republic of Nigeria, 1999 (as Amended), in my opinion, I certify that the Financial Statements Numbers 1, 2, 3 and 4 i.e. Statement of Cash Flow; Statement of Assets and Liabilities; Statement of Consolidated Revenue Fund, and Statement of Capital Development Fund together with their related Notes set out on pages 41 to 95 give a true and fair view of the state of affairs of the Government of Borno State as at 31<sup>st</sup> December, 2018.

### 2.0 GENERAL OBSERVATIONS:

### 2.1 Internal Audit and Internal Control

The pattern and manner in which the accounting books and records are maintained as observed in most of the Ministries, Departments and Agencies (MDAs) during routine examination of their records indicated inadequate control system. The shortcomings noted are highlighted below:

- Improper classifications of payments to the Economic Codes;
- Many payment vouchers raised were lacking the necessary documentary evidences to justify the payments made. This include documents like approvals for the expenditure, receipts, Store Receipt Vouchers (SRV) for supplies or purchases which shows that they are either not supplied or not taken on charge;
- Some vouchers were not signed by the relevant parties to the payment vouchers like signatures of the Officer controlling Vote (i.e authorizing Officer), the payee etc;
- Most Cash Advances, which come as Imprests were not retired in most of the MDAs;
- Deductions made in respect of Withholding Tax (WHT) and Value Added Tax (VAT) have no supporting documents;
- In some cases payment vouchers were not checked by Internal Auditors and where they do, they only stamp the vouchers after payments have been made thus defying the essence of the audit.
- ➤ The Internal Audit certification on payment vouchers and other accounting books and records examined which should best be authenticated by "Internal Audit Stamp" as set out in Financial Regulation No.1710, is

lacking or has not been complied with by most of the Internal Auditors. They have rather been using a Green pen to tick, which is restricted to the members of the Office of the State Auditor General as far as accounting books and records are concerned thus, contravening provisions of Financial Regulations No.3002.

Inexperience or lukewarm attitude on the part of some accounts staff in attaching supporting documents to payment vouchers is very prevalent in most of the MDAs.

### Recommendations:

The above shortcomings are the very more reasons for most of the Audit Queries issued. And these can be reduced if not eliminated through:

- i. Effective supervision and continuous training of concerned officers by both the Accounting Officers and the Office of the Accountant General.
- The Accountant General must empower the Inspectorate Unit of the Department of Inspectorate and Internal Audit to conduct constant visitation of Ministries, Departments and Agencies (MDAs) with a view to inspect and effect correction of observed errors immediately as they occur
- iii. The Accountant General should also reinvigorate the sense of responsibility and powers of Internal Auditors in discharge of their duties. If they can rise to the occasion, there would be great improvement in payment vouchers documentation.
- iv. Accounting officers, Directors of Finance and Accounts and staff should embrace the Internal Audit functions as paramount without which the accountability process is incomplete.

### 2.2 Submission of Important Financial, Budgetary and Administrative Documents.

As observed under Internal Audit and Internal Control in Section 2.1 above, there were also lapses in the Submission of some Important Financial, Budgetary and Administrative Documents. This has been reported in my previous reports and yet they persist without any remedy. The importance of these documents cannot be overemphasized, because they help to avail timely, relevant and reliable financial and management information for management decision. However, it is unfortunate that in recent times, and even in the year under review (i.e.2017), copies of Contract Agreements; Approvals for Employment; Council Conclusions on Government programmes and activities; copies of Conveyance of Approvals for Payments by Ministry of Budget and Planning etc. for different recurrent and capital projects were not forwarded to the Office of the State Auditor General, and where they are forwarded, it used to be very much untimely.

#### Recommendation:

In view of the above, this Office wishes to emphasize the need for:

- i. Accounting Officers to put in more synergy towards ensuring efficiency in government business. That is ensuring that relevant documents, information etc. are made available to the Office of the Auditor General or his staff as the case may be.
- Proper Implementation of the International Public Sector Accounting Standards (IPSAS), the importance of which includes; Greater Disclosure of Information, leading to Transparency; Integrity; Accountability and Comparability will greatly mitigate against the challenges or shortcomings of submission of copies of Contract Agreements; Approvals for Employment; Council Conclusions on Government programmes; copies of Conveyance of Approvals for Payments and Establishment circulars etc. and shall no longer be a tedious task.
- iii. Ensure effective circulation of government circulars, policies and programs to relevant government bodies.

### 2.3 Pension and Gratuity

In the year 2018, one thousand and sixty nine (1069) files were processed in respect of mandatory, voluntary retirement and withdrawal of service which involved the sum of one billion and seven million eight hundred and eight three thousand five hundred and fifty four naira and eight kobo (\$1,007,883,554.08) only for pension while gratuity was the total sum of three billion three hundred and twenty four million five hundred and fifty four thousand six hundred and eight naira and sixty four kobo (\$3,324,554,608.64).

Similarly one hundred and twenty nine (129) files were treated in respect of officers who died in active service, which involve the sum of three hundred and thirty nine million six hundred and thirteen thousand six hundred and eighteen naira and fifty kobo (N339,613,618.50) only for their five (5) years pension, while gratuity stood at the sum of two hundred and fifty eight million eight hundred and sixty one thousand four hundred and seventy naira and eighty eight kobo (N258,861,470.88) only.

Therefore the cumulative total of the mandatory and voluntary retirement, withdrawal of service and those who died in active service were one thousand one hundred and ninety eight (1198) files, which were processed involving grand totals of pension one billion three hundred and forty seven million one hundred and seventy two naira and fifty eight kobo (\$1,347,172.58) only and gratuity of three billion five hundred and eighty three million four hundred and sixteen thousand and seventy nine naira and fifty two kobo (\$3,583,416,079.52). The details of the above are tabulated according to Ministries, Departments and Agencies (MDAs) in the table below.

### Savings:

Savings of a total sum of seventy four million five hundred and seven thousand nine hundred and sixty two naira and sixty nine kobo (\N74,507,962.69) was made during audit of records of Retirement/ Death Benefits of officers the year 2018. The saving was as a result of officers who overstayed in service above the normal period either by age or by service or sometimes continuation of flow of salaries after an officer had retired or beyond date of death for officers who died in active service; which are pursuant to non-timely stoppage of retiring or deceased officers' salaries. The amount is regarded as overpayment and is endorsed against officers' Gratuity Payable for deduction.

### Recommendation:

- That Ministries, Department and Parastatals should draw a comprehensive Staff Nominal Roll, which will help monitor service period of their staff so as to advice and draw attention of all officers due to retire to submit in time their letter of notice of retirement.
- ii. Periodic orientation and sensitization of the state labour force the importance of adhering to timely exit to both the officer and the Government.

### 2.4 Audit Queries

For the accounting year 2018 a total of ten (10) Audit Queries so far were issued to two (2) Ministries, out of which none was cleared. Therefore, the ten (10) Audit Queries in respect of the two (2) Ministries remained unresolved as at the time of writing this report, which involve a total sum of thirty two million eight hundred and five thousand three hundred and twenty nine naira and forty three kobo (\$32,805,329.43). These queries were issued to the Ministries for lack of attaching the relevant supporting documents to the payment vouchers, non-signing of the payment vouchers by payees and other relevant officers, and incomplete documentations of the payment vouchers etc. These will be discussed further in this report.

### 3.0 ANALYSIS OF BUDGET PERFORMANCE

This segment of the report deals with the comparative analysis of the actual revenue generation performance and actual expenditure performance put against their approved budget for the year under review. The purpose is for ascertaining whether or not revenue targets were met; and the degree of their performance. Similarly, the expenditure aspect is evaluated to determine whether there was conformity or not with the expenditure projections as contained in the Appropriation Law of the year 2018.

The Year 2018 Budget was christened Budget of Resettlement and Empowerment, which is intended to primarily empower our people towards total resettlement and self-actualization.

In order to realize the year's objective of the budget, the 2018 budget had a budget size of One hundred and eighty one billion, eight hundred and twenty eight million, five hundred and fourteen thousand naira (\$181,828,514,000) only for both Capital and Recurrent expenditure. The Capital expenditure was put at one hundred and eighteen billion six hundred and forty six million five hundred and eighty three thousand naira (\$118,646,583,000) only while the recurrent expenditure was put at sixty three billion one hundred and eighty one million nine hundred and thirty one thousand naira (\$463,181,931,000) only.

The budget was expected to be financed by Statutory Allocation from the Federation Account of one hundred and twenty six billion three hundred and twenty two million one hundred and ninety seven thousand naira (\$126,322,197,000) only; Capital Revenue of thirty six billion nine hundred and thirty million seven hundred and sixty nine thousand naira (\$36,930,769,000) only; Internally Generated Revenue (IGR) of sixteen billion and

seventy five million five hundred and forty eight thousand naira (\$16,075,548,00) only; and an Opening balance of two billion and five hundred million naira (\$2,500,000,000.00) only.

### 3.1 Recurrent & Capital Revenue Performance

### Recurrent Revenue Performance

The recurrent revenue estimate was predicted on receipts from the Internally Generated Revenue (IGR) and federation Account Allocation.

### Internally Generated Revenue (IGR) Performance

In the year 2018, the actual Collection for Internally Generated Revenue (IGR) was six billion eight hundred and twenty two million one hundred and eight thousand nine hundred and eighteen naira (N6,822,108,918) only out of the budgeted figure of sixteen billion and seventy five million five hundred and forty eight thousand naira (N6,075,548,000) only. The performance of the actual Internally Generated Revenue (IGR) to the budgeted figure and other details are tabulated in the below table.

By comparing the total Actual Internally Generated Revenue (IGR) collection with the budgeted figure in the above table, it can be observed that 42.44% represents the actual collections, while 57.56% of the budgeted IGR could not be accessed, which is translated as revenue shortfall for the year 2018. However, in terms of actual collection figures, the year 2018 collections exceeded that of year 2017 by 38.86% which is equivalent to the sum of  $\Re$ 1,909,063,364 only.

### Federation Account Allocation Performance

The approved budget for revenue from the Federation Account Allocation was a total of one hundred and twenty six billion three hundred and twenty two million one hundred and ninety seven thousand naira (N126,322,197,000) only; the actual collection on the other hand was eighty two billion eight hundred and fifteen million and thirty two

thousand three hundred and thirty four naira (\$82,815,032,334) only, which represents 65.56% of the approved budget, indicating a shortfall of 34.44%. Furthermore the receipts from the Federation Account Allocation for the year 2018 exceeded that of 2017 by sixteen billion eight hundred and sixty million six hundred and eighty thousand and forty six naira (\$16,860,680,046) only.

In the same vein, the actual revenue from the federation Account Allocation represents 91.86% of the total Actual Recurrent Revenue of the State for the year under review. The detail is presented in the table below:

### Capital Revenue Performance.

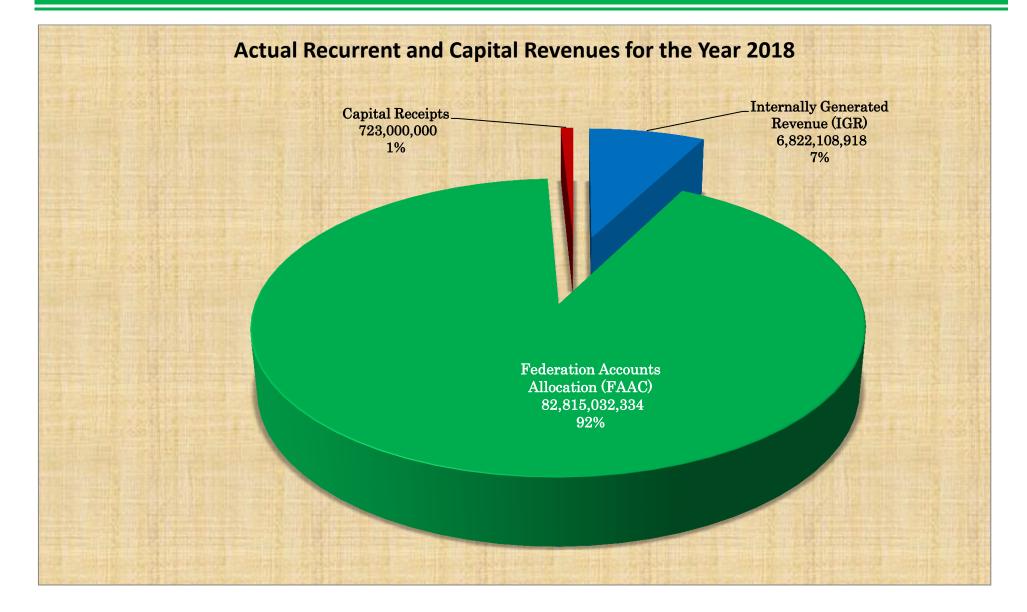
The approved budget for Capital Receipt for the Year 2018 was a total sum of thirty six billion nine hundred and thirty million seven hundred and sixty nine thousand naira (N36,930,769,000) only, and the actual receipt was a total sum of seven hundred and twenty three million naira (N723,000,000) only. This represents 1.96% of the total estimated grants and receipts for the year under review, and therefore, revealing a deficit of N36,207,769,000 representing 98.04% the budget. The details are tabulated hereunder:

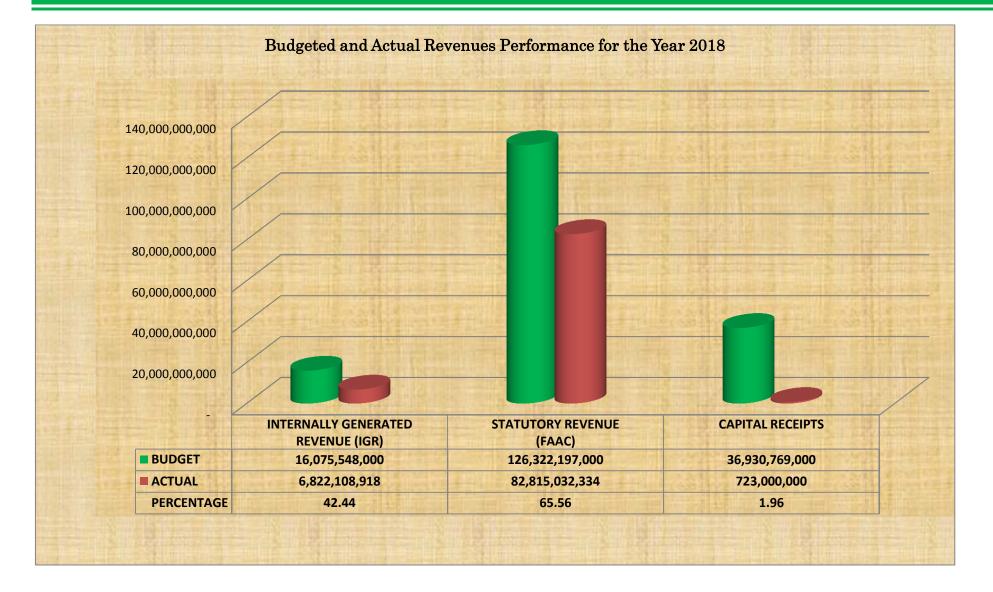

Comparing the actual Capital Receipts for the year 2018 with that of 2017, receipts in the year 2018 is lesser by \$7,532,000,000, which represents 91.24%.

The Recurrent and Capital Revenues presented above are further analyzed in chart forms as follows:





### 3.2 Revenue Shortfalls:

As observed in paragraph 3.1 above, the total shortfall from the budgeted Internally Generated Revenue (IGR) for the year 2018 was a total sum of nine billion two hundred and fifty three million four hundred and thirty nine thousand and eighty two naira (N9,253,439,082) only, which represent 57.56% of the Internally Generated Revenue (IGR) budget arising from all the Revenue codes.

Nevertheless, of more concern are the revenue codes of some Ministries, Departments and Agencies (MDAs) where there were no collections of a single kobo made from them, i.e. no revenue was realized from them. Out of the budgeted Internally Generated Revenue (IGR) figure of sixteen billion and seventy five million five hundred and forty eight thousand naira (\$16,075,548,000) only, Revenue Codes with budgeted sum of eight billion two hundred and fifteen million one hundred and sixty five thousand naira (\$8,215,165,000) have been observed to have Zero collection. #### Recommendation

- i- Centralize the issuance of the Revenue Collectors' Receipts and the Treasury Receipt.
- ii- Improve the supervision of Revenue Collectors by conducting a periodic random inspection of the Revenue Collectors' activities by superiors.
- iii- Strengthening existing institutional and regulatory framework as it relates to revenue generation through review of existing Revenue Laws of revenue generating Ministries, Departments and Agencies (MDAs) in line with international best practice, and then eliminates or expunges obsolete or non-existent revenue type(s) or source(s) from the budget.
- iv- Ensure adequate database of all taxable/revenue generating entities.
- v- That there should be effective collaboration between the revenue generating Ministries, Departments and Agencies (MDAs), and Board of Internal Revenue Service and Office of the Accountant-General for adequate accounting and recording of revenue generated.

### 3.3 Recurrent Expenditure Performance

Recurrent expenditure refers principally to expenditure on operational activities i.e. running cost, wages and salaries, (which include pension and gratuity), procurement of goods and service, current grants and subsidies and servicing of loans/debt (both internal and external) etc. And so the recurrent expenditure budget for the year 2018 was sixty three billion one hundred eighty one million nine hundred and thirty one thousand naira (N63,181,931,000) representing 34.75% of the total budget for the year. The actual performance was a total sum of forty seven billion one hundred and twenty two million and forty four thousand two hundred and seventy seven naira (N47,122,044,277) representing 74.58% of the Recurrent expenditure budget for the year under review. The details are tabulated blow:

Therefore, as shown in the above table, the overall performance of the recurrent expenditure in relation to the budgeted provision showed an impressive performance of 74.58%. In the same vein, the individual components of the recurrent expenditure showed a commendable performance in the range of 31% to 96%.

# 3.4 Capital Expenditure Performance.

The Capital expenditure performance analyzes the infrastructural facilities and service provided to the citizenry. The sectors performances explain the type of services provided to the people. Analysis of sectoral performances is done by matching the actual against the budget provisions on basis of the sectors, which are tabulated below:

As shown in the table above, the overall performance of 2018 capital expenditure was 34.66%, meaning that from the approved budget of one hundred and eighteen billion six hundred and forty six million five hundred and eighty three thousand naira (\$118,646,583,000) only, the sum of forty one billion one hundred and seventeen million one hundred and sixty five thousand eight hundred and ninety four naira (\$41,117,165,894) only was the actual expenditure for the provision of infrastructural facilities and basic service to the citizens, which stood at 34.66% as indicated above, where 65.34% of the budget could not be realized.

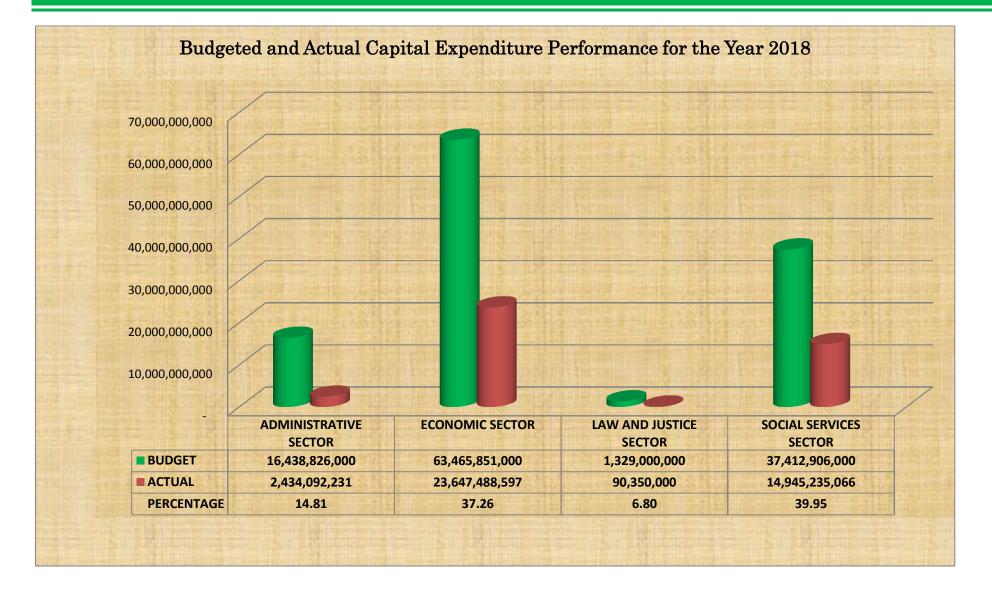
Nevertheless, the actual performance for the year under review exceeded slightly that of the year 2017 in terms of actual amount spent, indicating a gradual improvement in provision of basic facilities and service. However, in terms of percentage performance in relation to the budgets of the years 2017 and 2018, performance of the year 2018 exceeded that of the year 2017 by 4.49%.

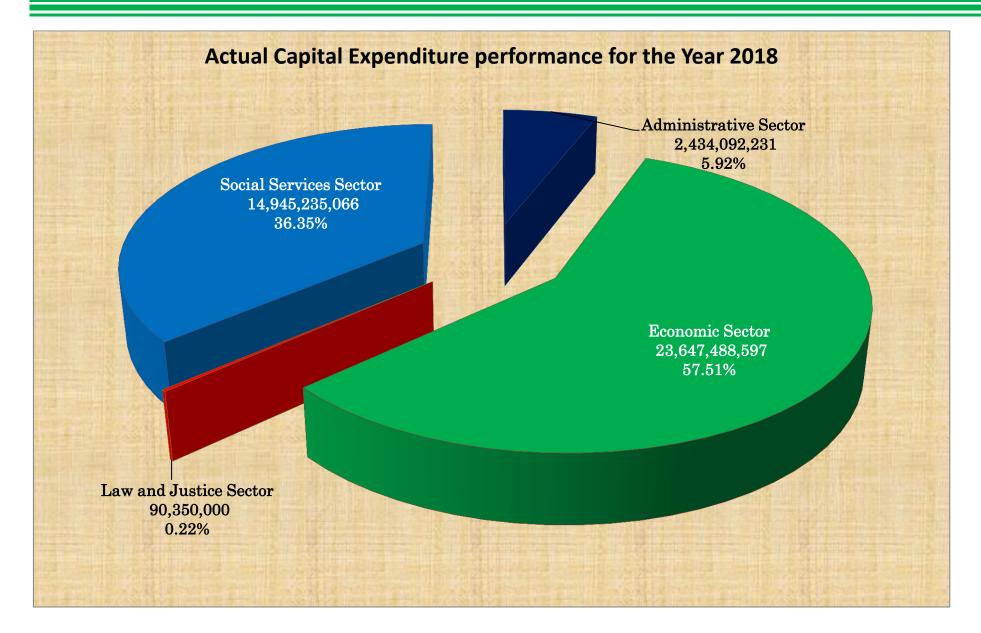
Similarly, while matching the actual expenditure of a sector against its budgeted provision, the following performances were revealed: Social Services Sector showed performance of 39.95% and rated the most significant performance; Economic Sector and Administrative Sector followed with 37.26% and 14.81% respectively, while Law and Justice Sector accounted for 6.80% performance. And by comparing the sectoral performances for the years 2017 and 2018, only Administrative Sector's performance that showed decrease from 14.87% in the 2017 to 14.81% in the year 2018, while the remaining three sector's performances revealed increase as follows:

- Economic Sector from 30.33% in 2017 to 37.26% in 2018
- Law and Justice Sector from 4.94% in 2017 to 6.80% in 2018
- Social Services Sector from 37.44% in 2017 to 39.95% in 2018

While the above analysis was by putting the Actual Expenditure against the Budgeted Expenditure, analyzing the group (sectors) actual expenditure on pie chart presentation revealed that the Economic Sector accounted for 57.51% of the total actual capital expenditure for the year; Social Services Sector - 36.35%; Administrative Sector indicated 5.92%, while Law and Justice Sector stood at 0.22%.

The above analysis are here presented on a bar chart for the comparison of Budgeted Capital Expenditure and the Actual components, while a pie chart presentation is made for the Sectoral performances of the Actual Expenditure. These are shown below:





# 4.0 MINISTRIES, DEPARTMENTS AND AGENCIES.

This segment of the report deals unresolved observations arising from the routine audit of Ministries, Departments and Agencies (MDAs) in respect of recurrent (i.e. Salaries and Overhead) and capital expenditures; inspection of offices and stores and revenue. These observations, which are in the form of queries or reports were brought to the attention of the Accounting officers for their necessary action to resolve them, however, up to the time of writing this report these observations remained unresolved due to either no reply or unsatisfactory replies.

The detail of the Audit Queries and or Reports which have not been resolved as at 31<sup>st</sup> December, 2018 and up to the time of writing this report are indicated below and the affected Ministries, Departments and Agencies (MDAs).

# 4.1 Ministry of Reconstruction, Rehabilitation and Resettlement:

### Audit Queries

During the audit of the payment vouchers for both Capital and Overhead Cost expenditures for the year 2018, nine (9) payment vouchers were observed not to have been attached the relevant supporting documents, thus resulting into querying these payment vouchers, which involve the total sum of thirty million nine hundred and thirty two thousand eight hundred naira (N30,932,800.00) only.

The attention of the Accounting officer was drawn to these queries where he was requested to comment there on, but his reply has not been received up to the time of writing this report. The details are shown below:

# 4.2 Ministry of Poverty Alleviation and Youth Empowerment:

## Audit Queries

During audit of payment vouchers for other charges (Overhead Cost) and Capital expenditures for the year 2018, one (1) payment voucher involving a sum of one million eight hundred and seventy two thousand five hundred and twenty nine naira and forty three kobo (\$1,872,529.43) only was queried for lack of attaching the relevant supporting documents to the payment voucher.

The attention of the Accounting Officer was drawn to the anomalies where he was requested to comment on the query; his reply has not been received up to the time of writing this report.

# 5.0 PARASTATALS AUDIT

The auditing of Boards and Parastatals is conducted in accordance with the provisions of Section 125(3-4) of the Constitution of the Federal Republic of Nigeria 1999 (As Amended), while auditing of Government Companies is guided by the Companies and Allied Matters Act (CAMA), 2004.

The position of audited accounts for Boards and Parastatals as at 31st July 2019, are as follows:

One (1) Agency, that is, Borno State Primary Health Care Development Agency (SPHCDA) has been audited up to the year ended 31<sup>st</sup> December, 2018; while two others are being audited for the year 2018. These are:

- i. Borno State Roads Maintenance Agency (BORMA)
- ii. Borno State Urban Planning and Development Board

The following Six (6) Boards and Parastatals have been audited up to year ended 31<sup>st</sup> December 2017 where audit for year 2018 is ongoing in two (2) of them as indicated above:

- i. Kashim Ibrahim College of Education, Maiduguri
- ii. Borno State Board of Internal Revenue
- iii. Borno State Universal Basic Education Board (SUBEB)
- iv. Borno State Housing Corporation;
- v. Borno State Primary Health Care Development Agency (SPHCDA)
- vi. Borno State Roads Maintenance Agency (BORMA)

The following five (5) other organizations have submitted their Draft Account for audit for year indicated against them. Three (3) of the organizations' Draft Accounts have been submitted up to year 2018, and one (1) has engaged Auditors and auditing is in progress, while the rest are yet to; and these include:

- i. Abba Ashigar College of Business and Administrative Studies Konduga; Accounts for 2012 2017
- ii. Borno State Urban Planning and Development Board; Accounts for 2016 2018 (Auditing is ongoing)
- iii. Ramat Polytechnic Maiduguri; Account for 2016 only
- iv. Borno Express Transport Corporation; Accounts for 2016 2018
- v. Borno State Pilgrims Welfare Board; Accounts for 2013 2018

Twenty two (22) others are currently being audited for the various periods to  $31^{st}$  December 2018 by Firms of Chartered Accountants. This came as an intervention by the former Governor, His Excellency Hon Kashim Shettima who approved the payment of the Auditors Fees as requested by the Auditor General. These organizations have been lagging behind with arrears of unaudited accounts for periods ranging between four (4) to seventeen (17) years. These include:

- i. Borno state Sports Council
- ii. El-Kanemi Warriors Football Club
- iii. Borno Radio Television (BRTV) Corporation
- iv. Borno State Council for Arts and Culture
- v. Islamic Religion Preaching Board
- vi. Mohammed Goni College of Legal and Islamic Studies

- vii. School of Higher Islamic Studies
- viii. Borno State Agricultural Development Programme (BOSADP)
- ix. Borno State Library Board
- x. Borno State Environmental Protection Agency (BOSEPA)
- xi. College of Education Waka-Biu
- xii. Borno State Agricultural Mechanization Authority (BOSAMA)
- xiii. Borno State Education Endowment Fund
- xiv. Borno State Agency for Mass Literacy
- xv. Borno State Scholarship Board
- xvi. Council for Prerogative of Mercy
- xvii. Borno State Nomadic Education
- xviii. Borno State Islamic Research Centre
- xix. Teaching Service Board (TSB)
- xx. Borno State Afforestation Project
- xxi. Borno State Hotels Limited
- xxii. Maiduguri Kano Motor Park and Market

However, the following organizations have not shown readiness for the audit of their records, that is they are yet to submit their Draft Account to the Office of the Auditor General to pave way for the audit. These are as follows:

i. Hospitals Management Board (HMB); last audit was 1995

- Umar Ibn Ibrahim El-Kanemi College of Education, Science and Technology, Bama; last audit was 2010, however, the college came under attack of the insurgents
- iii. Borno State Rural Electrification Board (REB); last audit was year 2006
- iv. Mohammet Lawan College of Agriculture; last audit was year 2004
- v. Borno State Rural Water Supply Agency (RUWASA); last audit was 2003

As I made mention in my previous reports, the inability of auditing these organizations as at when due is worrisome and not healthy for government business, considering the huge sum of money spent on these organizations in terms of salaries and other recurrent and capital projects. Timely information from audited accounts which is very helpful for management decision purposes is virtually lacking here. And the primary reason given for the inability to engage services of auditors has been lack of fund to pay Audit fees.

Despite the competing demands, it is my opinion that Government must rise up to her responsibility by taking positive steps towards ensuring the audit of the State Boards, Commissions, Agencies, Corporations and Parastatals; that funds should be provided for the payment of Audit fees through the Office of the State Auditor General. This will enhance quality work/reports, objectivity in reporting and independence of the Auditors and as well as timely completion of the work.

## Recommendation:

It is Audit opinion that auditing of Government Boards and Parastatals is essential and constitutional and the importance too cannot be overemphasized. And therefore urge government to:

- i. Despite competing demands, funds should be provided for the payment of Audit fees to external auditors that may be engaged
- The funds for the Audit fees should be under the custody of the Office of the state Auditor General. This will enhance the quality of the work or reports, objectivity and independence of the Auditors and as well as timely completion of the work,
- iii. Appoint Board members to Parastatals: the importance of Board members cannot be overemphasized,
   because vital decision making on policy matters and supervision affecting the Parastatals can best be made
   by Board members in accordance with the laws establishing them.

# 6.0 STAFF MATTERS:

In the year 2018, the Office of the State Auditor General had staff strength of one hundred and twenty four (124) at the beginning of the year, and due to retirement and transfer the staff strength reduced to one hundred and fifteen (115) staffs of all cadres.

Currently, as at 31<sup>st</sup> July 2019, the Office of the State Auditor General has staff strength of one hundred and eight (108) and as a result of massive retirement a big vacuum is created thereby making short supply of manpower generally. In view of this, the Office of the State Auditor General is requesting for the recruitment of officers in order to fill up the gaps.

Similarly the Office is short of adequate functional motor vehicles for the day to day running of her activities. Travels to conduct, especially verification of capital projects executed by Government spread across the State have been difficult if not impossible. Apart from the Official car of the Auditor General, there are only two (2) aged Peugeot Pick-up and Station Wagon, which are grossly inadequate for effective discharge of the functions of the Office. Added to this is the issue of funding.

It is therefore my humble request that Government should prioritize the Office of the State Auditor General by granting the Office adequate financial autonomy for effective and efficient discharge of the statutory functions bestowed upon her in order to help ensure accountability, probity and transparency in government business.

## **RESPONSIBILITY FOR THE FINANCIAL STATEMENTS**

The Financial Statements and their related Notes on pages 41 to 95 have been prepared in accordance with the provisions of the Public Finance (Control and Management) Act 1958 CAP 144 LFN 2004 (as amended). The Financial statements were prepared on the bases of Nigerian Format of Cash Basis International Public Sector Accounting Standards (IPSAS) and they comply with the Generally Accepted Accounting Principles (GAAP).

As the Accountant General of the State, I am the Chief Accounting Officer of the receipts and payments of all government funds. I take appropriate steps to fulfill my financial reporting responsibilities. I am responsible for establishing and maintaining adequate system of Internal controls; and that the system provides adequate and reasonable assurances that transactions are appropriately recorded and are within statutory authority. I ensure that proper accounting records are maintained and that judgments and estimates are reasonable and relevant to the content of the Financial Statements. I also ensure and take responsibility for the integrity and reliability of the Financial Statements.

I confirm that the Financial Statements reflect the financial position and operations of the State Government as at December 31, 2018. The Accountant General accepts responsibility for the integrity of this Financial Statements and their compliance with the Finance (Control and Management) Act 1958 as amended.
