The provisions of the Ekiti State Fiscal Responsibility Law, No. 12 of 2019 (in this Law referred to as "the Principal Law" is amended as set out in this Law.

Debt and Indebtedness.

Amendment of 2. Section 34 (1) (b) of the Principal Law. Section 34 (1) (b) of the Principal Law is hereby deleted and substituted with another Section 34 (1) (b) as follows:

(b) The State Government shall ensure that the level of public or internal debt as a proportion of the State income is held at a sustainable level as prescribed by the House of Assembly from time to time on the advice of the Fiscal Responsibility Commission and the Debt Management Office.

Citation.

3. This Law may be cited as Ekiti State Fiscal Responsibility (First Amendment) Law, 2020.
