A BILL FOR A LAW TO AMEND THE OGUN STATE PUBLIC PROCUREMENT LAW, 2014

(Date Assented to/Vetoed)

BEIT ENACTED by the House of Assembly of Ogun State, Nigeria as follows:

This Law may be cited as the Public Procurement (Amendment) Law, 2020.

2. Section 2 of the Principal Law is hereby amended:

 By inserting the definition of the word "Governor" immediately after the definition of the word "Goods" as follows:

"Governor" means the Governor of Ogun State;"

(b) By inserting the definition of the word "State" immediately after the definition of the phrase "Solicitation Documents" as follows:

"State" means Ogun State of Nigeria;"

Section 4 of the Principal Law is hereby amended as follows:

a) By deleting sub-paragraph (v) of sub-section 1 (b) thereof and replacing
it with a new sub-paragraph (v) as follows:
 *(v) A Special Adviser to be appointed by the Governor;

(b) By deleting paragraph (c) of sub-section (1) thereof and replacing it

with a new paragraph (c) as follows:

"(c) Five (5) other members who are stakeholders in the procurement sector, appointed by the Governor on part time basis."

(c) By deleting sub-section (4) thereof and replacing it with a new subsection (4) as follows:

*4.The Members of the Council other than ex-officio members and the Director-General (whether appointed from within or outside the Civil Service), shall hold office for a period of four (4) years and may be re-appointed for one further term and no more.

(d) By deleting sub-section (8) thereof and replacing it with a new subsection (8) as follows:

8. The members of the Council shall be paid such remunerations, emoluments, allowances and benefits as may be approved by the Governor. Provided that the ex-officio members of the Board shall only be entitled to sitting allowance.
