1 Summary of Performance

1.A Introduction

This Budget Performance Report for Nasarawa State is prepared quarterly, and issued within 4 weeks from the end of each quarter.

This report includes, the approved budget appropriation for the year 2022 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q₁, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations. Performance is assessed against the Original budget.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21, and Economic Account Class 2201
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2208

1.B Revenue Performance

The State realised a total of N21,687,334,543.61 as revenue for the period under review. Making a percentage performance of 19.6% of the total expected revenue of N110,849,954,879.49 for the FY 2022. There are overcollections in few revenue items such as Other Revenues were N172,466,377.98 was generated against N60m budget in the State College of Education, Akwanga and N252,963,318.71 realised against N40m budget for Nasarawa Geographic Information System (NAGIS). Again, Vehicle Inspection Service Charge under Ministry of Works, Housing and Transport has exceeded the revenue projection for the year as N15m was estimated to be generated for FY 2022 and within the first quarter of the year, the revenue items got N19,948,047 during Q1.

1.C Recurrent Expenditure Performance

The State Government spent a total of N14,345,615,995.26 (19.9%) on recurrent expenditure and about N8,671,933,977.64 was for the payment of personnel cost as well as pension and gratuity. Key challenge is the issue of MDAs who could not submit their monthly and quarterly performance report. These MDAs include; State House of Assembly, Office of the Head of Civil Service, Rural Water Supply Agency, Sharia Court of Appeal, Ministry of Youth & Sports Development, College of Health Science, and Liaison Office. Appropriate measured will carried against these MDAs.

In addition, there are expenditures that exceeded budgetary provision for the year. This is basically due to under budgeting. Items include: 22020706-SURVEYING SERVICES (NAGIS) in which N20m was budgeted and N51.9m was expended; Foreign loan repayment (Principal) stands at N141.2m against N244,657.78 and Foreign Loan Repayment (Interest) with N39.3m actual against N115,601.15.

1.D Capital Expenditure Performance

Based on available data from MDAs, the State spent N3,793,612,354.13 for capital expenditure as against N38.9bn budgeted for the year, representing 9.7%.

1.E Conclusions

The State got a total revenue of N21,687,334,543.61 including opening balance and out of this N18,139,228,349.39 was spent for both recurrent and capital expenditures. The Q1 budget expenditure added value to the ongoing capital projects such as the Bus terminals at Karu and Lafia, dualization of Shendam Road and other roads across the State among others. Recurrent expenditure items include; payment of salaries, pension and gratuities, security support, and other spendings to run governance in the State.
