# **1** Summary of Performance

# **1.A** Introduction

This Budget Performance Report for Nasarawa State is prepared quarterly, and issued within 4 weeks from the end of each quarter.

This report includes, the approved budget appropriation for the year 2021 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations. Performance is assessed against the original budget since no supplementary or revised budget has been passed to date.

The core economic classifications refer to:

Personnel – Economic Sub-Account Type 21 and Account Class 2201

Overheads - Economic Account Class 2202

Capital - Economic Sub-Account Type 23


Others - Economic Account Classes 2203-2207

This Budget Performance Report is produced by the Department of Budget, Ministry of Finance, Budget & Planning, Nasarawa State, and published on the Nasarawa official State website.

# **1.B** Revenue Performance

Nasarawa State realised a recurrent revenue of N17,519,905,283.49 as against the total recurrent revenue of N83,613,808,360.89 representing 21.0%. Recurrent revenue consists of share of FAAC (N11,348,973,261.48) and Internally Generated Revenue (N6,170,932,022.01). On the other hand, the sum of N356,285,013.95 was realised from capital receipts as against N27,602,798,162.27. This represents 1.3% of the total expected inflow from capital receipts.


The overall revenue (including opening balance) within the period under review stood at N23,859,209,419.24 as against the expected sum of N28,930,703,635.75 for the first quarter. This represents 82.47% performance within the reviewing period.



# **1.C** Recurrent Expenditure Performance


Recurrent expenditure comprises personnel cost, overhead cost and other expenditure for debt servicing. Nasarawa State spent N6,824,514,294.35 for payment of salaries and other emoluments representing 18.9% of the total anticipated sum of N36,143,276,005.28.

On the other hand, N31,294,483,612.00 was planned to be expended on overhead (Government running cost). As at the end of the first quarter, the sum of N4,297,179,991.96 was actually expended, representing 13.7% of the total allocation for the year.



# **1.D** Capital Expenditure Performance

Within the period under review, the sum of N4,770,542,904.47 was spent on capital projects, mostly infrastructure such as the roads, buildings and equipment. This is 9.9% of the total capital allocation of N48,285,054,925.73.



# **1.E Conclusions**

In summary, Government intended to provide optimal service in this FY, and from the analysis above, it could be deduced that the first Quarter (Q1) Budget performance was fair implying that Government is on track. The budget implementation report for Q1 shows that Government's overall planned expenditure stood at Twenty-Eight Billion, Nine Hundred and Thirty Million, Seven Hundred and Three Thousand, Six Hundred and Thirty-Five Naira, Seventy-Five Kobo (N28,930,703,635.75.00) only. From this, Government was able to meet up with basic budgetary provision of Civil Servants salaries, pensions/gratuities of retirees, settled part of contractual liabilities, government running cost and some capital spending to the tune of Fifteen Billion, Eight Hundred and Ninety-Two Million, Two Hundred and Thirty-Seven Thousand, One Hundred and Ninety Naira, Seventy-Eight Kobo (N15,892,237,190.78) only for the above budget components. It is hopeful, however, that the next budget implementation reports for the remaining quarters will have a desirable performance.
