1 Summary of Performance

1.A Introduction

This Budget Performance Report for OGUN State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes the approved original budget appropriation for the year 2021 (no supplementary or revised budget has been passed to date in 2021) against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q2, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations. Quarter 2 performance is assessed against the original budget since no supplementary or revised budget have been passed to date in 2021.

The core economic classifications refer to:

- Personnel – Economic Sub-Account Type 21
- Overheads - Economic Account Class 2202
- Capital - Economic Sub-Account Type 32
- Others - Economic Account Classes 2203-2208 as applicable

This Budget Performance Report is produced by the Ministry of Budget and Planning and published on the Ogun State website.

1.B Revenue Performance

The 2021 Budget will rely more on and be financed by the IGR from the Ogun State Internal Revenue Service and other MDAs due to the drastic dwindling of about 45% reduction from the Federal Account Allocation Committee (FAAC). More-over, recovery from the economic downturn triggered by the Covid-19 pandemic last year, necessitates deepening our diversification drive in different sectors such as agriculture; investment, trade and industry; culture and tourism; solid mineral, etc. Determined to further improve IGR, the State through the recently inaugurated Lagos Ogun Joint Development Commission (LOJDC), will further consolidate on revenue and tax management, especially in the border towns. We have much to gain from efficient and effective enumeration and data sharing of citizens resident in border town areas, and efficient and regular remittances of personal income taxes of Ogun residents working in Lagos State. This direction will obviously increase taxable persons and reduce tax leakages.

A global summary of the State's revenue profile is broken down as follows:

(A) As at the beginning of 2021 financial year, out of a total of N18,405,526,771.63 opening balance at the on-set of the 2021 budget preparation, a sum of N11,421,932,997.21 was expended, translating to 62.1%

of the projection while the balance in the sum of N6,983,493,774.42, that is, 37.9% of the original budget was available as cash and cash equivalent to finance 2021 budget.

(B) Internally Generated Revenue (IGR): This is also referred to as Independent Revenue in the template. A total sum of N121,806,876,775.63 has been appropriated, out of which a sum of N54,823,454,354.03 had been generated as at Q2, that is 45.01% performance. However, proportionately, the target at Q2 is a sum of N60,903,438,387.81 of which a sum of N54,823,454,354.03 had been realized at Q2, translating to 90.02% proportionate performance.

(C) Other Funding Sources of N198, 398,539,474.60 is made up of Government share of FAAC (STATUTORY REVENUE) of N58,871,016,616.18 i.e (Statutory Allocation of N39,675,563,607.41 and Value Added Tax of N19,195,453,008.77) AND Capital Receipts of N134,367,566,858.42

(i) Government share of FAAC (STATUTORY REVENUE), that is, Statutory Allocation and Value Added Tax. A sum of N16,099,931,507.63 was realized from Statutory Allocation while the actual receipts from Value Added tax amounted to N11,881,588,269.15 as at the end of Q2. This translating to 81.16% and 123.80% proportionate performance respectively. However, included in the Statutory Allocation was the sum of N1,910,455,574.86 being the inflow from Excess Crude, Exchange Gains, Non-Oil Proceeds etc as at the end of Q2.

(ii) Capital Receipts comprise; Aids and Grants (N5,159,956,000.00) AND Internal and External Loans (that is, CAPITAL DEVELOPMENT FUND CDF RECEIPTS of N134,367,566,858.42). However, out of the sum of N5,159,956,000.0 budgeted as an inflow from Grants for 2021 fiscal year, only N1,868,215,860.12 has been realized as at the end of Q2 or 36.21% performance, while proportionately this translates to 72.41% performance. The State in Q2 accessed the sum of N9,832,518,517.89 as Internal Loans which represent 10.27% performance and 20.55% proportionate performance. Although the State was able to draw-down some Inflows from External Loans particularly World Bank Finance Projects such as Ogun State Economic Transformation Project (OGSTEP), Nigeria Erosion and Watershed Management Project (NEWMAP), Covid-19 Action Recovery and Economic Stimulus (CARES), Program, etc. However, inflows could not be included in this report simply because the return was filled after the reconciliation and finalisation of the half-year report. Amongst such receipts include the sum of \$2,725,704.12 for OGSTEP, \$1,000,000.00 for NEWMAP and N872,215,860.12 for SAVING ONE MILLION LIVES PROJECT. The State shall include all these inflows and the expenditures therewith in the Q3 report.

(D) The reason the State Civil Service Commission exceeded her budgeted revenue for 2021 FY as at half-year as reported was due to the commencement of the outstanding promotion exercise both in the Public and Civil Service as approved by the Governor.

Owing to the large number of eligible personnel across all MDAs, we had a high rate of over 80% of the total staff strength in the service of the Ogun State Government who paid for the examination forms. Hence, the exponential increase in the revenue generated and reported by the Civil Service Commission. In addition, the Ministry of Finance surpass the Revenue target as at the end of Q2 due to the inflow from the Land Use and Amenities charges.

(E) The Total Revenue as at the end of Q2 amounts to N101,489,202,283.24 out of original budget of N338,610,943,021.86, translating to 29.97% performance at Q2. Proportionately, this is a target of N169,305,471,510.83 at Q2, representing a proportionate performance of 59.94% at Q2.

There is no doubt that the revenue performance most especially the Internally Generated Revenue performed had improved tremendously when compared with the Q1 performance. This was mainly due to the inflow from the Land Use and Amenities Charges, Back-duty and Tax investigation/monitoring exercise and introduction of Central Billing System. The State shall continue exploring every opportunity in income generation by deepening the IGR and blocking of all revenue leakages as well as ensuring that the citizens comply with taxes and rules and regulations on revenue.

1.C Recurrent Expenditure Performance

The key economic goals of the Government will continue to be pursued, which are- Real Sector Growth; Job Creation; Poverty Eradication and Increased Investments. These have been encapsulated in the Five Strategic Pillars coined as I. S. E. Y. A (INFRASTRUCTUR; SOCIAL WELFARE AND WELL-BEING; EDUCATION; YOUTH EMPOWERMENT; AGRICULTURE). The total budget size of N338,610,943,021.86 appropriated for Y2021 is made up as follows:

RECURRENT EXPENDITURE

(A) The appropriation for Personnel Cost was a sum of N92,643,072,156.99, out of which a sum of N35,343,986,232.58 had been expended, translating to 38.03% performance. Proportionally, this represents a sum of N46,471,536,078.77 as target for Q2, out of which the sum of N35,343,986,232.58 was expended, amounting to 76.06% performance proportionately.

(B) Other Recurrent Costs (which consists of the Overhead Costs and the Public Debt Charges) for 2021 fiscal year was N74,069,732,138.19, out of which a sum of N15,261,094,453.71 was expended, translating to 20.60% at Q2. Proportionally, the target is a sum of N37,034,866,068.79 amounting to 41.21% proportionate performance.

(C) A further breakdown of the Other Recurrent Costs of N74,069,732,138.19 is as follows:

(i) Overhead Cost of N54,933,731,418.87 Appropriation, out of which a sum of N10,623,660,449.41 was expended, translating to 19.34%. Proportionally, this is a target of N27,466,865,709.44 at Q2, translating to 38.68% proportionate performance at Q2.

(ii) Other Recurrent (Public Debt Charges) of N18,836,000,718.71 Appropriation, out of which N4,637,434,004.20 was utilized at Q2, representing 24.62%. Proportionally, this is a target of N9,418,000,359.36 at Q2, amounting to 49.24% proportionate performance at Q2.

(D) We envisage that there is going to be an improvement in personnel cost performance from Q3 once the on-going promotion exercise is concluded which affect more than half of the State workforce. It must be noted that the financial implication of the promotion exercise was factored into the year 2021 budget.

(E) The overhead cost would also record an improved performance in Q3, the State government will continue to release running cost to MDAs while fund would also be made available to MDAs for other government activities.

1.D Capital Expenditure Performance

(A) The State Government will give utmost priority to capital project investments in Education; Health; and Infrastructure Sectors (as pillars towards mitigating the effects of the Covid-19 pandemic) as well as steps towards economic recovery.

(B) Non-Current Assets – a total sum of N171,898,138,726.69 has been appropriated this 2021 fiscal year, out of which a sum of N22,798,242,491.11 was expended at Q2, representing 13.26%. Proportionally, this amounts to N85,949,069,363.36 as at Q2, representing 26.53% proportionate performance at Q2.

(C) Total expenditure for Q2 stood at N73,403,323,177.40, out of the approved budget size of N338,610,943,021.86 for 2021 fiscal year, amounting to 21.48% performance at Q2. The proportionate target is N169,305,471,510.93 at Q2 with the actual performance of N73,403,323,177.40, representing 43.26% proportionate performance at Q2.

(D) The Capital Expenditure performance is bound to improve tremendously in the course of time. The State Government had released fund to contractors for the completion of various projects across the nooks and crannies of Ogun State to ensure accelerated growth and even development across the 3 Senatorial Districts of the State. Further to this, the State has embarked on the construction of Agric Airports, and other strategic collaborations such as the LOJDC which will foster physical planning and urban development, slum regeneration as well as tackling environmental challenges such as flooding, dredging, waste management and pollution control.

1.E CONCLUSION

Ogun State government has continually kept creating an enabling environment for industrialization to thrive. We anticipate a robust budget performance in Q3 and far beyond because of measures which the government had introduced to boost IGR e.g., incentives like tax holidays for prospective investors, block leakages as well as various reforms geared to promote efficiency and effectiveness in fund allocation and utilization. Enablers to drive these various programs and projects will receive the much-needed attention to drive economic growth. In the last 2 years of the incumbent administration, we have witnessed reconstruction and completion of well over 270.88 kilometers 34 roads and rehabilitation of well over 322.627 kilometers of 41 roads across the State. Other key sectors including healthcare delivery, education, affordable housing projects, agricultural development, digital and technological revolution, better sports development, improved welfare of workers, shall be given the acceleration deserved.
