1 Summary of Performance

1.A Introduction

This Budget Performance Report for Nasarawa State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes the approved original budget appropriation for the year 2021 (no supplementary or revised budget has been passed to date) against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q2, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

The core economic classifications refer to:

- Personnel – Economic Sub-Account Type 21, and Economic Account Class 2201
- Overheads - Economic Account Class 2202
- Capital - Economic Sub-Account Type 23 / 32
- Others - Economic Account Classes 2203-2207

This Budget Performance Report is produced by the Department of Budget, Ministry of Finance, Budget and Planning, Nasarawa State, and published on the Official State website.

1.B Revenue Performance

Nasarawa State realised a recurrent revenue of N15,851,454,665.17 for Q2, making a total of N33,371,359,948.66 for Half Year 2021 as against the total recurrent revenue of N83,613,808,360.89 representing 39.9%. Recurrent revenue consists of share of FAAC N12,053,659,755.41 which is higher than N11,348,973,261.48 for Q1 and Internally Generated Revenue of 3,797,794,909.76 far lower than N6,170,932,022.01 in Q1. On the other hand, the sum of N2,798,395,597.76 was gotten in Q2, higher than Q1 capital receipts of N356,285,013.95. The total capital receipts for both Q1 and Q2 stood at N3,154,680,611.71 as against N27,602,798,162.27. This represents 11.4% of the total expected inflow from capital receipts.

The overall revenue (including opening balance) within the period under review stood at N40,763,902,054.24 as against the expected sum of N57,861,407,271.5 for the Half Year. This represents 70.45% performance within the reviewing period.

1.C Recurrent Expenditure Performance

Recurrent expenditure comprises personnel cost, overhead cost, and other expenditure for debt servicing. Nasarawa State spent N6,742,625,036.24 in Q2 making a total of N13,567,139,330.59 for Q1 and Q2 for payment of salaries and other emoluments representing 37.5% of the total budgeted sum of N36,143,276,005.28.

On the other hand, N31,294,483,612.00 was planned to be expended on overhead (Government running cost). As at the end of the Second quarter, the sum of N8,082,160,847.69 was expended, representing 29.5% of the total allocation for the year.

1.D Capital Expenditure Performance

Within the period under review, the sum of N 4,043,704,688.22 was spent on capital projects, mostly infrastructure such as the roads, buildings, and equipment. Total capital expenditure for the half year 2021 stood at N8,814,247,592.69. This is 18.3% of the total capital allocation of N48,285,054,925.73.

1.E Conclusions

Nasarawa State Government plans and actions look ideal in this FY, and from the analysis above, it could be deduced that the first Half Year (H1) Budget performance was fair, implying that Government is on track. The budget implementation report for Q1 and Q2 indicated that Government's overall planned expenditure was able to meet up with basic budgetary provision of Civil Servants salaries, pensions/gratuities of retirees, settled part of contractual liabilities as well as capital expenditures.
