### 1 Summary of Performance

#### 1.A Introduction

This Budget Performance Report for Adamawa State is prepared on quarterly basis and issued within four weeks from the end of each quarter.

This report includes the original approved budget appropriation for the year 2023 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter (i.e. first quarter), attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q1 report is assessed against the 2023 Original Budget

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2209 as applicable
- This Budget Performance Report is produced by the Office of the Accountant General in conjunction with the Budget Department, Adamawa State, and published on the Adamawa State website (www.budgetoffice.ad.gov.ng).

#### 1.B Revenue Performance

The State Government budgeted the sum of N175.019 billion as Total revenue for the year 2023. The sum of N134.291 billion being recurrent revenue while N40.727 billion for capital receipts. The State realized the sum of N24.393 billion for recurrent revenue, representing 18.2% of the total budgeted recurrent revenue.

#### 1.C Recurrent Expenditure Performance

The recurrent expenditure budget stood at N105.011 billion for the fiscal year 2023. The state recorded a performance of 10.9% having spent 11.417 billion in first quarter of 2023. The actual performance of 11.417 billion is represented by N6.420 billion and N4.997 billion being personnel cost and other recurrent cost respectively.

#### 1.D Capital Expenditure Performance

The approved budget for Capital expenditure for the year 2023 is N70.007 billion. The actual expenditure to date on infrastructure development of the State stood at N4.329 billion.

#### 1.E Conclusions

Overall, the performance of the State Government for period ended 31st march, 2023 is considered fair in terms of revenue generation, and expenditure execution amidst volatile economic conditions.
