1 Summary of Performance

1.A Introduction

This Budget Performance Report for Borno State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes the original approved budget and appropriation for the year 2023 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q2, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q2 report is assessed against the 2023 Original Budget.

The core economic classifications refer to:

- Personnel – Economic Sub-Account Type 21
- Overheads - Economic Account Class 2202
- Capital - Economic Sub-Account Type 23
- Others - Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Ministry of Finance, Budget and Economic Planning and published on the www.pfm.bo.gov.ng State website.

1.B Revenue Performance

The Total Recurrent Revenue performance in the 2nd Qtr. seems to be low (N25,344,739,240.38) which is about 39.8% of the 2023 budgetary provision, this is regardless of the fire outbreak in the three major markets in the state which are, Monday Market, Gamboru Market and Biu market, these also made the second quarter revenue of the state to be low. While growth in IGR was envisaged, notwithstanding the generally low economic activity occasioned by the insecurity in certain areas of the State. The IGR of about N3,714,778,439.63 representing 31.9% Of the budgeted figures. There is however room for improvement in Q3 as government is intensifying more efforts towards IGR.

Aids & Grants and Capital Receipts performance is low in 2nd quarter 2023. The performance in Q2 is generally low due to dwindling FAAC allocation and non-receipt of aids and grants.

Total Capital receipts of N1,098,742,500.92 representing 4.6% of the budgeted figures is also very low in Q2. The problems bedevilling the gathering of information for Actual Aids & Grants has persisted despite improvement in the 4th quarter of 2022. The main drawback is that some MDAs are under reporting or out rightly fail to report on Actual Aids and Grants and other Capital Receipts. However, more efforts are being made to increase information sharing across MDAs with a view to improve on report and returns on capital receipts in the 3rd QTR. The relatively poor performance of Grants and Loans is weighing on overall budget performance but hopefully, these items would catch up in the third quarter of the year. The State has accessed to get N10 billion domestic loan and is being negotiated out of the N25 billion estimated.

The second quarter actual total revenue of N26,443,481,741.30 (Twenty-Six Billion, Four Hundred and Forty-Three Million, Four Hundred and Eighty-One Thousand, Seven Hundred and Forty-One Naira, Thirty Kobo) being 37.9% of the budget size was recorded for both Recurrent Revenue and Capital Receipts.

1.C Recurrent Expenditure Performance

The 2nd quarter recurrent expenditures is in line with the current administration's policy of paying Salaries and Pensions as at when due, thus monthly payment of Salaries, Pensions and Gratuity arrears and regular release of Overhead Costs to MDAs has continued, showing that the Actual recurrent expenditure recorded as at the end of Q2 for FY2023 was N13,747,797,071.56 (Thirteen Billion, Seven Hundred and Forty-Seven Million, Seven Hundred and Ninety-Seven Thousand, Seventy- One Naira, Fifty- Six Kobo) representing 28.6% of 2023 Budgeted figure. The recurrent expenditure comprises of Personnel cost of N7,749,688,313.31 representing 37.4%, Overhead cost of N3,285,932,305.89 representing 16.8% and other recurrent costs representing about 22.6%. However, there is need for more efforts to be made to improve the performance in respect of social contribution in the 3rd QTR.

1.D Capital Expenditure Performance

The Actual Capital Expenditure Performance for the Second Quarter (Q2) for FY2023 stood at N11,517,597,651.74 (Eleven billion, Five Hundred and Seventeen Million, Five Hundred and Ninety-Seven Thousand, Six Hundred and Fifty- One Naira, Seventy- Four kobo), representing 15.5% of the 2023 budgeted figures. However, the capital expenditure performance in Q2 is better-off than in Q1, showing that some MDAs have complied with the rules. Therefore, the low performance may be as a result of low Capital inflows from budgeted sources and/or non-capture of some capital expenditure from some MDAs due to persistent late submissions of returns.

1.E Conclusions

The Second quarter (Q2) 2023 Actual Recurrent Revenue and Actual Recurrent Expenditure Budget Performance are favourable. However, there is need for more efforts to be made to improve the performance in respect of Capital Receipts (4.6%) and Capital Expenditure (15.5%) as these performances are very poor. Thus, the aggregate expenditure performance is low, which is largely due to the fire outbreak in the three main markets in the State and nonrealization of capital receipts. In conclusion, Budget amendments has been made for all overspent items against the original Budget. Borno State having commenced the implementation of the Public Financial Management (PFM) reforms with computerisation and automation of systems, efforts will be geared towards ensuring correct and timely electronic submission of returns by all MDAs to facilitate the production of more robust and comprehensive Budget reports in remaining two (2) quarters of the FY 2023.
