## **1** Summary of Performance

This Budget Performance Report for Imo State is prepared quarterly and issued within four weeks from the end of each quarter.

This report includes the approved budget appropriation for the year 2021 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the first quarter, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations. Quarter 1 performance is reviewed against the original 2021 budget. No supplementary or revised budget has been passed to date in 2021.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2207.

## **1.A INTRODUCTION**

This report is the First quarterly budget appraisal or implementation report for 2021 in accordance with Budget of Wealth Creation of 3R Government of **His Excellency Senator Hope Uzodimma** meticulously package by the Ministry of Budget, Economic Planning & Statistics. Previous administration through the office of Accountant General have refused to make Financial Statistics available to perform this obligation because of the opaque nature of previous Government Fiscal accountability and transparency. The present Government led by **His Excellency, Senator Hope Uzodimma** believes in transparency and willing to render Account *Budget Performance Report - 2021 Quarter 1* 

of stewardship to the people of Imo State. Thus, the need to re-engineer and better the economic life of Imolites formed the road map for critical review of the quarterly performance of the MDAs in line with the National Chart of Account compliance, Careful assumptions were drawn after appraisal of the global economic trend that inform both our economic and fiscal updates for the 2021 budget.

However, before the commencement of the new budget cycle, the Ministry of Budget, Economic Planning & Statistics reviewed the previous performances, taking into cognizance the fragile crude oil and its dwindling revenue consequence on Naira value. The need to operate a realistic, transparency and accountability budget on the budget size of about **\#346,176,722,084.58 billion in 2021 (tilted Budget of Wealth Creation).** 

It is encouraging that despite the numerous economic challenges inherent in the present administration, the global economic lock down occasioned by the Coronavirus Pandemic, the State has maintained a fair economic stability. Hence, much has been achieved through prudent economic management and the financial prowess of the present administration ably led by **His Excellency**, **Senator Hope Uzodimma**.

I wish to thank the staffs of Ministry Budget, Economic Planning & Statistics who painstakingly put together this report, Office of Accountant General of the State who honored our request by releasing vital fiscal Statistics which enable us to present this first quarter report for the 2021 Budgetary monitory and evaluation, in accordance with the SFTAS requirement of World Bank.

# **IMO STATE CONSOLIDATED BUDGET SUMMARY 2021**

The Sum of **346,176,722,084.58** was appropriated by the Imo State House of Assembly for 2021 Fiscal Year. This Approved budget has a recurrent expenditure of **\+74,643,881,943.30** representing 21.5% while the Capital Expenditure is **\+271,532,840,141.28**, representing 87.5% of the total budget size. Therefore, the recurrent expenditure has a quarterly budget of **\+18,660,970,485.83** and Capital expenditure **\+67,883,210,035.32** in 2021 Fiscal year.

## Fiscal Analysis of the 2021 Budget Appraisal or Performance

2021 Approved Budget of Imo State signed into Law in December 2020, Adopted Federal Government 2021 Budget Assumption such as:

- 1. Crude oil benchmark of \$40per barrel
- 2. Oil production estimate of 1.86Million barrels per day
- 3. Exchange rate of ₦379 per US\$
- 4. Inflation rate of 14.23%
- 5. GDP Growth rate (real) of 3%

## **1.B Revenue Performance**

The following Subheads make up the Recurrent Revenue item:

## **INTERNAL GENEERATED REVENUE (IGR)**

A sum of **₦18,824,382,442.15** was budgeted for IGR in the first quarter of the year 2021 but the actual inflow is **₦8,389,532,168.64** representing 44.2% Performance in the period under review(Q1)

## **STATUTORY ALLOCATION**

In first quarter of 2021 Budget, Statutory Allocation was budgeted with **₩8,081467765.25** but the actual generated was **₩7,975,255,806.00** representing 96.2% performance in the period under review (first quarter)

## VALUE ADDED TAX (VAT)

The sum of **3,470,169,999.25** was budgeted for Value Added Tax in the first quarter of 2021 budget but it recorded **5,244,167,454** as actual in the quarter under review (first quarter) representing 151% performance in the quarter.

### **13% DERIVATION FUND**

Derivation Fund was budgeted with the sum of **2,441,377,610.25** in the first quarter of the 2021 Budget but recorded **2,299,425,277.00** as actual in the first quarter of 2021 representing 94% performance in the first quarter of 2021.

**Exchange Gain Difference** was budgeted with the Sum of **\#1,202,013,275.75** in first quarter of 2021 Budget but it recorded **\#35,819,370.00** as actual inflow in the first quarter 2021 representing 3% performance, while **Excess Bank Charges** was Budgeted **\#2,414,244.25** in the first quarter 2021 but it recorded **\#3,688,990.53** as actual in the first quarter showing150.6% showing increase in performance. The **Forex Equalization Account** recorded **\#256,622,574.00** as actual inflow in first quarter of the Fiscal year 2021.

## **1.C Recurrent Expenditure Performance**

## **RECURRENT EXPENDITURE PERFORMANCE IN 1<sup>st</sup> QUARTER**

The following Subheads make up Recurrent Expenditure item.

## **1. PERSONNEL COST**



The budgeted Personnel Cost for 2021 Approved Budget was **#** 3,530,020,571.25 (Three Billion, Five Hundred and Seventy-One Naira, Twenty-Five Kobo) only in the first quarter while the actual was **#**4,631,667,688.41 (Four Billion, Six Hundred and Thirty-One Million, Six Hundred and Sixty-Seven Thousand, Six Hundred and Eight-Eight Naira, Forty-One Kobo) only, representing **131.2%** performance. These shows that the salaries and allowances of Civil Servants and Political office holders were paid as at when due.

## 2. OVERHEAD

The sum of **#8**,430,911,227.50 (Eight Billion, Four Hundred Thirty Million, Nine Hundred and Eleven Thousand, Two Hundred and Twenty-Two Naira, Fifty Kobo) was budgeted for Overhead Costs in the first quarter of the approved 2021 budget but the actual spent was **#6**,135,494,700.50 (Six Billion, One Hundred and Thirty-Five Million, Four Hundred and Ninety-Four Thousand, Seven Hundred Naira, Fifty Kobo) only representing **72.7%** performance.

## **3. SUBVENTION**

The Sum of #3,365,579,099.50 (Three Billion, Three Hundred and Sixty-Five Million, Five Hundred and Seventy-Nine Thousand, Nine Hundred and Ninety Naira Fifty Kobo) only was appropriated for Subvention in the first quarter of year 2021 but the actual inflow on subvention within the period under review (first quarter) was #2,773,031,830.00 which representing 82.4% performance.

## 4. CONSOLIDATED REVENUE FUND CHARGES (CRFC)



The sum of #3,334,549,587.00 (Three Billion, Three Hundred and Thirty-Four Million, Five Hundred and Forty-Nine Thousand, Five Hundred and Eighty-Seven Naira) only was budgeted for CRFC in the first quarter of 2021 approved budget, but there was no available data on the actual as at the time of writing the first quarter report.

### **5. PENSION**

The sum of **#2,582,283,438 (Two Billion, Five Hundred and Eighty-Two Million, Two Hundred and Eighty-Three thousand, Four Hundred and Thirty-Eight Naira)** only, was the actual inflow spent for the first quarter of the year 2021 which representing 75% performance.

## 6. COVID-19 EXPENDITURE

**The Sum of N384, 460, 000.00** (Three Hundred and Eighty-Four Million, Four Hundred and Sixty Thousand Naira), was the actual spent on Logistics to various Isolation centre in Imo State, Additional logistics for wave of second Covid-19 and Logistics for Covid-19 vaccines. This representing 8% performance in the first quarter of the year under review 2021.

## **1.D Capital Expenditure Performance**

A whopping sum of **#67,881,432,536** (Sixty-Seven Billion, Eight Hundred and Eighty-One Million, Four Hundred and Thirty-Two Thousand, Five Hundred and Thirty-Six Naira only) was earmarked for Capital Projects in 2021 approved budget for the first Quarter of the year. This is to provide infrastructural projects for the well-being of Imolites.

However, from the available records, it was observed that a total sum of **#8,909,296,122.30 (Eight Billion, Nine** *Hundred and Nine Million, Two Hundred and Ninety-Six thousand, One Hundred and Twenty-Two Naira Thirty Kobo Only*, was released for Capital projects during the period under review (January – March 2021),

representing 131.1% performance in the first Quarter. This shows a remarkable decrease in what was budgeted for in the first quarter of the year and what was spent.

It was also observed that it was only the Economic and General Administration sectors that executed some projects in the first quarter of 2021.

## CAPITAL RECEIPTS PERFORMANCE FOR THE FIRST QUARTER (JANUARY - MARCH 2021).

## **INTERNAL LOANS:**

The State has a quarterly budget of N9,567,500,000 in the 2021 Budget but has received nothing as Internal loan in the first quarter of the year under review (2021)

## **DEVELOPMENT PARTNERS**

Imo State has a quarterly budget of N69,075,000 in the 2021 budget but has received nothing in the first quarter of 2021.

## GRANTS

The State has a quarterly budget of N42,885,780,184 expected to be realized from Grants but nothing has been received so far in the first quarter of 2021.

## **1.E.** Conclusions

In conclusion, the 2021 Approved Budget can be said to be a Child born and brought up in an exceedingly difficult environment. The overall first quarter performance of 2021 approved Budget was adversely affected by the Global 2020/2021 problem called COVID-19 or the Corona Virus Pandemic. This problem saw crude oil price crashing to a low level of below USD20 per barrel. This affected the Revenue inflow in terms of Statutory Allocation.

The lockdown hampered economic activities and frustrated revenue collection. The expected First Quarter Revenue target was **34,020,137,837** but only **24,204,511,640.64** or **72%** was realized, including Statutory Allocation.

IGR recorded **8,389,532,168.**64 or 44.4% performance for the State, instead of **18,822,694,942** targeted.

On the Recurrent Expenditure side, it recorded an impressive performance as it recorded 72% only out of targeted recurrent expenditure of **18,661,060,485.25** only **13,437,349,251.73** was spent in the First Quarter.

Personnel Cost recorded 130.5% indicating that salary was promptly paid even as it recorded increased Personnel Cost. Additional logistics for wave of second Covid-19, Logistics to various Isolation centre in Imo state and Logistics for Covid-19 vaccines, this representing 8% performance from Actual budgeted in 2021.

In conclusion, we can commend the **EXECUTIVE GOVERNOR OF IMO STATE, SENATOR HOPE UZODIMMA**, who has been able to meet the obligations to the people of Imo State, despite the harsh economic climate occasioned by the Global Crisis because of the Corona Virus Pandemic. This is the second time Imo State First Quarter Budget analysis is going public in the last 18years, in compliance with World Bank SFTAS requirement.

This is because of transparency and openness of this administration and the dynamism of the best Commissioner for Budget; Economic Planning & Statistics Imo State has ever produced in the person of **Rt. Hon. Dr.C.C. Osuala PhD.** Statistical information which are hardly released to do this work; he has been able to convince our new and vibrant Accountant General to release data as it will do the State good and not harm as erroneously believed by the previous administrations. May this good work started by the Hon. Commissioner never stop at this edition. The World Bank Grants received through SFTAS makes the publication of First Quarter 2021 report a revenue generating concern for the betterment of Imo State.
