1 Summary of Performance

1.A Introduction

This Budget Performance Report for Kano State is prepared on quarterly basis, and issued within four weeks from the end of each quarter. The report assesses the performance of Kano State 2021 Budget for the period of January-March 2021 in respect to Revenue, Personnel Cost, Overhead Cost and Capital Expenditure.

This report contains detail approved budget appropriation for the year 2021 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter one (1st quarter), attributed to each organizational unit, as well as the cumulative expenditures, and balances against each of the revenue and expenditure appropriations. Quarter 1 performance is assessed against the 2021 original budget. No supplementary or revised budget has been passed to date in 2021.

The core economic classifications refer to:

- Personnel – Economic Sub-Account Type 21, and Economic Account Class 2201
- Overheads - Economic Account Class 2202
- Capital - Economic Sub-Account Type 23
- Others - Economic Account Classes 2203-2206

This Budget Performance Report is produced by the Ministry of Planning and Budget in collaboration with the Ministry of Finance, and published on the Kano State's website.

1.B Revenue Performance


The Revenue comprises of Recurrent Revenue and Capital Receipts. Recurrent Revenue consists of Statutory Allocation, Value Added Tax, Other Statutory Allocation and Internally Generated Revenue (Tax and Non Tax Revenue). While Capital Receipt consist of Grants, loans and other extraordinary items or Unspecified Revenue.

Recurrent Revenue

Actual performance of Statutory Allocation from January-March 2021 recorded was N11.2 Billion against N52.2 Billion representing 21.4% achievement. While Value added Tax of N9.2 Billion was actualised in the First quarter of 2021. This depicted 32.4% achievement on Value added Tax.

Similarly, Performance of Internally Generated Revenue was N6.2 Billion against the Approved Projected of N25.2 Billion, which depicted 24.7% achievement. The Table below depicted the graphical presentation of the recurrent revenue performance for the period of January-March 2021.


Recurrent Revenue Composition (Budgeted Vs Actual)




The table below depicted aggregated components of Recurrent Revenue (Combination of Statutory Allocation, Value Added Tax and Internally Generated Revenue) and Capital Receipt (Combination of Grants, loans and other Unspecified and Extra Ordinary Revenue). The Approved Recurrent Revenue for the Year 2021 Fiscal Year was **₦107.8 Billion** and the actual for the Recurrent Revenue from January-March was **₦27.017 Billion**. In terms of performance related to Capital receipts of **₦69.8 Billion** is discouraging as zero Performance was recorded as shown in Table below.

1.C Recurrent Expenditure Performance


Personnel Expenditure consists of payment of Salaries workers, pensions and gratuity to Civil and Public Servants and Retirees. The sum of N60.9 Billion is dedicated for that purpose. From the Graph below the actual Collection for the Period of January-March 2021 was N11.941 Billion depicting 19.6% achievement.



In the case of Overhead cost, which is payment of running cost to the MDAs, Judiciary and Kano state House of Assembly, the sum of N16.9085 was dedicated to cater for the above Expenditure. The actual performance of the Overhead reached N3.5 Billion for the first quarter of 2021 Fiscal Year, which depicted 22% achievement. Table below provide hint of the foregoing trend.



Other Recurrent(2203-2206)



On the side of other recurrent Expenditure, which has a total approved provision of N6.4 Billion and the actual expenditure from January- March 2021 was N148.6 Million indicated 2.2% achievement.

1.D Capital Expenditure Performance

On the Capital Side, the total sum of N94.4 Billion was approved to Finance Various Programmes and Projects in the Fiscal Year 2021. Performance report on the Capital Expenditure for the Period of January-March 2021 indicated 6.8% achievement as N6.4 Billion was released.

1.E Conclusions

The Total Recurrent Revenue performance for the First Quarter was N27.017 Billion against the Approved Budget of N107.8 Billion. This indicated 25.1% achievement in the First Quarter of the 2021 Fiscal Year.

The Recurrent Expenditure Performance that consists of Personnel and Overhead Cost was N15.6 Billion representing 19.6% achievement in the 1st Quarter of the 2021 Fiscal Year against the N83.4 Billion dedicated to the Recurrent Expenditure Side.

Zero percent in relation to Capital Receipt Performance as no any draw down was recorded in the first quarter against the approved budget of N69.8 Billion.

The Total Budget Expenditure which include both Recurrent and Capital Expenditure was N22.07 billion against the Total Budget of N177.9 Billion and performance was 12% achievement
