# 1 Summary of Performance

### 1.A Introduction

This Budget Performance Report for Niger State is prepared quarterly and issued within four weeks from the end of each quarter.

This report includes the original approved budget for the year 2023 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q1 report is assessed against the 2023 Original budget.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Account General Department/ Ministry of Finance/ Ministry of Planning and Budget/ Niger State equivalent and published on the Niger State website.

### 1.B Revenue Performance

### I. Government Share of FAAC (Statutory Revenue):

The sum of N100, 968,724,043 is budgeted to be realized as share of FAAC out of which the sum of \$\frac{\text{\text{\$\frac{4}}}}{22,135875,039.34}\$ representing 21%% was realised, during the first quarter of the year. This performance even though low, may likely improve in the course of implementation as improved economic activities is expected,moreso, as new administration is expected to be in place. Also, the opening of some posts will facilitate trade which will impact positively on revenue collection.

### II. Independent Revenue:

The sum of # 23,368,500,410.45 was budgeted out of which # 3,038,618,545.21 representing 13.0% was realised during the period under review. The dismay performance of IGR collection is to low level of economic activities as of electioneering activities. However, now that elections are over, it is expected that economic activities will pick-up coupled with the fact that the Niger State Board of Internal Revenue Service is repositioned for better performance

### III. Aids and Grants:

The sum of \(\pmax\_3,200,000,000.00\) representing 8.5% was realized out the approved estimate of N37,744,289,413.74. The low performance of this source could be attributed to the fact that most development partners activities normally pick-up in July and the fact that some are winding-up as the project life cycle has ended.

### IV. Capital Development Fund CDF (Receipts):

Capital Development Fund received a Budgetary Allocation of \(\pm\) 81,565,676,111.69 out of which the sum of \(\pm\) 647,955,599.50 or 0.8% was realised during the first quarter. This source of funding has enabled the government to implement its ongoing projects such as construction and rehabilitation of roads across the State, reconstruction of Government House and Governor's Lodge, Rehabilitation of Water works, Electrification work across the state amongst others.

### 1.C Recurrent Expenditure Performance

Total Budgeted Recurrent Expenditure of \(\pm\) 91,381,161,775.76 garnered a total of \(\pm\) 17,844,862,517.03 Or 19.5%. From the above total \(\pm\) 59,781,514,882.51 was allocated to personnel cost which received the sum of \(\pm\)-10,625,747,700.48 or 17.8% actuals. The remaining balance of \(\pm\) 31, 599,646,893.25 out of the total recurrent expenditure was allocated to Other Recurrent Costs which received the total sum of \(\pm\) 7,219,114,816.55 or 22.8% actuals. Expenses incurred under personnel cost were for payment of salaries and allowances while that of Other Recurrent were incurred to enable smooth running of Government and solve other arising issues such as security challenges..

### 1.D Capital Expenditure Performance

Capital Expenditure was allocated the sum of # 152,266,028,203.12 out of which the sum of # 8,723,518,991.50 or 5.7% was expended during the period under review on ongoing Projects in the areas of infrastructure, Water, Electrification and Public buildings across the state. Although the performance is low, it is expected that with completion of procurement procedures on projects, impressive performance will be recorded in the next quarter.

### 1.E Conclusions

The overall First Quarter Budget Performance Stood at 10.9%, this is due to the fact that it is a transition period and the fact that economic activities and that of development partners are yet to fully commence.

It is expected that in subsequent quarters ahead, there will be remarkable improvement in budget implementation.
