1 Summary of Performance

1.A Introduction

This Budget Performance Report for Taraba State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes the original approved budget appropriation for the year 2023 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q1 report is assessed against the 2023 Original

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Ministry of Planning and Budget and published on the Taraba State website.

1.B Revenue Performance

The bulk of the revenue expected for the quarter was from government share of Federation Account Allocation Committee (FAAC). It was expected that this source would bring in the sum of N69,662,234,050.11 for the First Quarter of the Year but data available shows that the sum of N17,112,581,633.96 was received from Government Share of FAAC (Statutory Allocation) in quarter one (Q1) or 23.3% year to date leaving a balance of N56,258,675,670.04 or 77.6%.

The Independent Revenue (IGR) estimated target was N19,388,694,342.40 but N3,076,925,204.71 or 15.9% was collected representing a good start performance as at first quarter of FY 2023, some Non-Tax IGR (1202) performed very low due to some national exercise (i.e., 2023 Presidential and State Elections).

In addition, revenue from Capital Development Fund (CDF) receipts that has flown into the state as at first quarter was N775,394,371.26 and as against Full Year budgeted figure of N39,954,044,775.00 and reflecting 1.9% in Q1. There was no draw – down from aids and grants.

1.C Recurrent Expenditure Performance

In recent years the state is keen on subjecting the recurrent expenditure to realistic projections to free more of its resources for capital development. A split of 60% for capital expenditure and 40% for recurrent expenditure was therefore projected in order to achieve the fiscal target of the state.

In the light of the above, the recurrent expenditure items approved figure was N74,556,829,088.15 with a performance of N12,795,746,705.65 representing 17.2% leaving a budget balance of N61,761,082,382.5 or 82.8%.. In addition, some of the expenditure line items has over performed or overspend, these will be carefully handled during the year through budget amendment.

1.D Capital Expenditure Performance

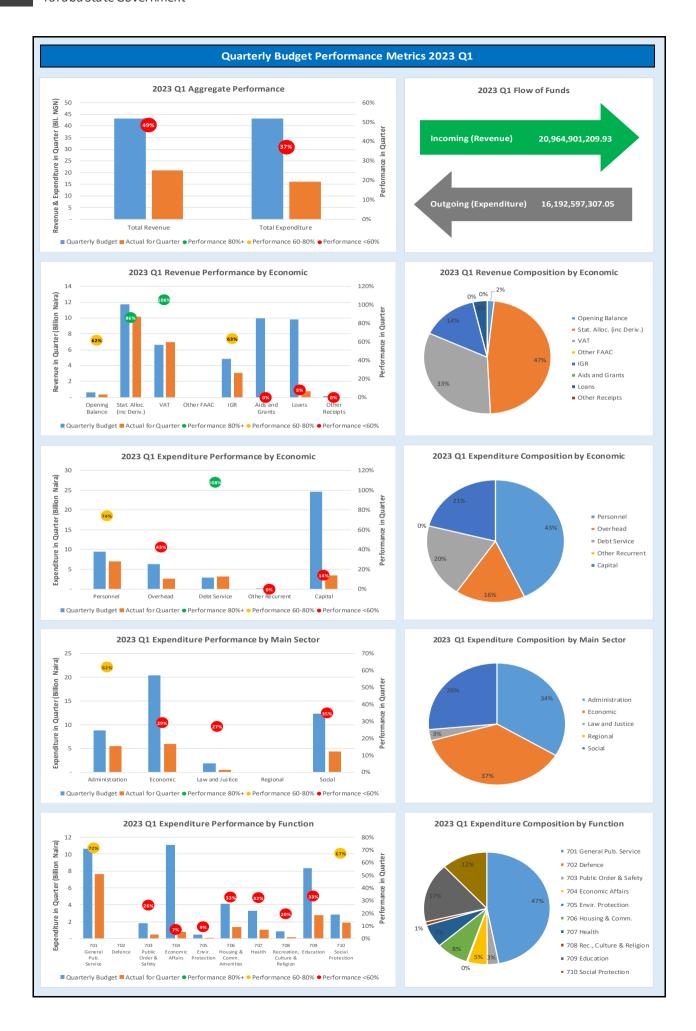
The capital expenditure is a pool of funds used for capital development. In view of its importance in the budget, it was allocated the sum of N98,677,708,371.25 which represents about 56.96% of the total budget size. However, actual capital expenditure performance stood at N3,396,850,601.40 performance as at the period under review (Q1) or 3.4%. This is not a fair performance when compared with previous years' budget performances.

1.E Conclusions

The 2023 budget aimed at restoring and stabilizing the state economy driven by the government's giant strides on the principle of transparency, accountability and citizen's participation in governance. It also aimed at making Taraba the leading economy in the North East sub-region by 2025.

Notwithstanding, the review of the 2023 Year – To – Date performance during the first quarter especially from the capital expenditure, shows a poor performance, though there is still room for improvement in the future. The state is making efforts to focus more on implementing capital projects and curtail recurrent expenditure to a minimal level for this will help the state to achieve its developmental targets.
