### STATEMENT OF ACCOUNTING POLICIES

The financial statements with the notes thereto reflect the financial position of Ebonyi State Government of Nigeria for the year ended 31<sup>st</sup> December, 2015. They show the various sources and uses of funds by the Government for the year under review.

The financial statements were prepared on the basis of the accounting polices stated below:

### **BASIS OF ACCOUNTING**

Both the accounting and financial statements were based on full cash basis and on historical cost.

### **ASSETS AND LIABILITIES**

Assets were stated at their net values while liabilities were recognized in full.

## **CAPITAL COST**

Capital costs were captured in the year acquired only.

Foreign currency transactions were translated into Naira, the reporting currency, using the exchange rate prevailing as at 31<sup>st</sup> December, 2015.

# **OVERHEAD COST**
