1. MESSAGE FROM THE BOARD

The Adamawa State Board Internal Revenue has developed a set of Consolidated State and Local Government Revenue Codes into a chart of accounts to meet up with global best practice in Treasury Single Account (TSA) operational system. The Chart of Accounts will be used in the preparations of Budget, Assessment, Accounting and Reporting Systems of the State and Local Government Revenue profile.

In line with the provisions of section 13 (3) of Adamawa State Revenue Administration Law 2020, the chart of accounts will provide basement for integrated tax administration system across the State and Local Governments.

In this chart, each MDA is given organizational code for reporting compliances in accordance with IPSAS Standard and global financial best practices. This is geared to enhance efficiency, accountability and transparency in Revenue budgeting and reporting by both tier of Governments (State and Local Governments).

The Revenue Codes on the Chart of Account are designed to simplified automatic retrieval referencing view on each Revenue Item/Title of the State Integrated portals linked to the TSA system. It gives the user liberty and comfort to view and query each remittance on the revenue profile process flow online, end to end simultaneously and seamlessly

In other words, the Revenue codes will perfect eagle eye viewing process on forensic revenue reporting.
